Cyber Crime Investigations

During my time in Idaho State Police (ISP) Investigations, I was assigned to the ISP Cyber Crime Unit (CCU) from January 2005 to 2008

I have performed and assisted with forensic data acquisitions using Guidance Software's EnCase v5.0-6.0 using DOS/Crossover/Hardware Write-Protection, Access Data's Forensic Tool Kit (FTK)/Imager/Password Recovery Tool Kit (PRTK), and various other software/hardware tools in criminal investigations from January 2005 to 2016.

My case experience numbers in the hundreds of cases either self-initiated or in assistance of outside agencies with investigations involving computer forensics, cell phone data acquisition, Digital Video Recorders (DVRs), internet investigations, and other forensic acquisitions of digital evidence contained on various digital hardware from January 2005 to 2016.

I have been trained in digital audio forensics modifying digital audio files to isolate and clean up audio signals ridding signal of extraneous and background noise.

Currently, I manage the ISP Cyber Crime Unit. In that capacity, I determine hardware/software needs of the Computer Forensic Examiners (CFE), review and approve reports, seek and assign necessary CFE training, and ensure proper evidence handling. I have established the Standard Operating Procedures Manual for the CCU and am currently working to get the CCU lab accreditation.

From 2016 to present, I have worked as Deputy Director (Sergeant) over the Idaho State Police, Idaho Criminal Intelligence Center, Idaho's sole Fusion Center, to manage day-to-day operations. I manage a total budget of over \$750,000.00 annually and have a staff of four full-time and ten part-time analysts. Fusion Centers were established to ensure smooth flow of information and intelligence from the federal level intelligence community to all first responders on the street, and vis-versa. The Center also provides robust case and investigative support for all Law Enforcement in Idaho.

I have managed a number of different programs for the Center: All training and travel for analysts, all computer hardware/software/network maintenance and intelligence database access maintenance for all analysts, the Center's first responder agency outreach Fusion Liaison Officer (FLO) program which encourages all first responders to participate in intelligence gathering, coordinating intelligence analysis with the Oregon-Idaho High Intensity Drug Trafficking Area (HIDTA), coordinating intelligence exchange and activity between the Department of Homeland Security (DHS) and the Center, quarterly reports on grant funded programs (Department of Homeland Security, State Homeland
