# Individualization of DNA Sources by STR Analysis (MBI-200)

### 1.0 Background/References

1.1 Once a DNA source has been detected and identified as to 'source type' where applicable and feasible, it is often important to attribute the DNA sample to a particular individual inasmuch as possible. Current DNA technology, in the analysis of STR loci, offers individualization potential. However, the individualization of a particular sample occurs through a comparative process. This process requires a DNA profile from a 'known' sample to which the evidence sample profile can be evaluated. DNA analysis will only be performed when all necessary 'known' or 'reference' samples, for the given case, have been submitted to the laboratory unless extenuating circumstances prohibit submission of such samples.

Although the analysis of STR loci offers individualization potential, analysis may not be necessary or performed on every case and/or sample submitted to the laboratory. DNA analysis will only be performed on cases and/or individual samples, which have the potential for resolving a probative and forensically significant question/issue regarding the given case, unless analysis is mandated by statute or court order. If the analysis of a sample resolves a given question, additional samples submitted for the resolution of the same question within the case will likely not be analyzed. Items for which DNA testing has already been performed will not be retested, except in the instance where new technology has become available and has the potential to resolve a question that could not be answered with the original technology. Additionally, DNA testing may establish identity, but does not establish timeframe or consent.

# Processing Liquid Blood (BI-100)

### 1.0 Background/References

1.1 Known reference standards in forensic casework may be received in the form of liquid blood, generally in a lavender top (EDTA) tube. The EDTA acts as a preservative for the DNA (even up to several years post-collection); however, if left in a liquid state for prolonged periods of time (especially post-mortem samples), these samples are more susceptible to degradation, potentially resulting in the loss of DNA. These liquid samples should be stored refrigerated to aid in their preservation until which time a bloodstain can be prepared. Bloodstains stored in a dry state, even at room temperature, may be suitable for DNA testing for many years. Bloodstains are to be prepared as soon as feasible following sample receipt (generally at the time of evidence analysis). However, if evidence processing is to be delayed beyond 2 months, it is recommended that any post-mortem blood samples associated with the case are checked out and bloodstains made for preservation.

### 2.0 Scope

2.1 To provide a method for the creation of stable DNA samples from blood.

### 3.0 Equipment/Reagents

- Blood Stain Card(s) (such as Whatman® non-FTA)
- Envelopes
- Disposable Transfer pipet or mechanical pipette with filter barrier tip

4.0 Procedure

- 4.1 Label stain card with a minimum of case number, item number, date and initials. Subject name may also be placed on the card for identification purposes.
- 4.2 Label blood sample tube with case number, item number, date, initials, and blood level. Mix the tube thoroughly by inversion.
- 4.3 Remove cap from blood tube and draw blood into pipet. Carefully spot, at minimum, 1 drop (~50μl) blood onto each circle.
- 4.4 Allow bloodstain card to air-dry completely before packaging.
- 4.5 Place the dried stain card into an envelope (~6½" x 9½"). Seal envelope with evidence tape on flap and label with initials and date across seal. The stain card will be sampled and given a sub-item number in ILIMS. An ILIMS barcode will be
  - printed and placed on the envelope containing the bloodstains.

NOTE: bloodstains associated with a sexual assault evidence collection kit will be placed back in the kit without an ILIMS barcode.

### 5.0 Comments

5.1 Exercise caution and wear appropriate protective gear when preparing bloodstains (e.g., gloves, lab coat, protective eyewear).

- 5.2 Bloodstains are to be prepared either in the hood with the sash at the appropriate level, or at a workbench while wearing a disposable face shield.
- 5.3 Only one blood sample source should be open at a time. When processing multiple samples, close one tube before opening another and make sure stains are placed sufficiently far away from a card being processed to avoid cross-contamination.

  - 4.2 Cotton swabs or a folded piece of filter paper are used to collect the suspected blood onto the tip. A swab may be moistened with sterile/nanopure  $H_2O$  if necessary.
  - 4.3 To the swab or filter paper with the suspected blood, add 1-2 drops of phenolphthalein working solution. Wait 10-15 seconds to detect potential false positives.
  - 4.4 Add 1-2 drops of 3%  $H_2O_2$  and note appearance or absence of bright pink color. Color reaction should occur rapidly ( $\leq 1$  minute).
  - 4.5 Document result in case notes. Record positive (+), as indicated by the development of the above color change, or negative (-) as indicated by the absence of the color change. Analyst may use other descriptive word(s) as well (e.g., strong, weak, slow, etc.).

- 5.1 Direct testing of a small cutting/sample may also be performed.
- 5.2 Color changes occurring prior to the addition of 3% H<sub>2</sub>O<sub>2</sub> are generally considered inconclusive.

### 4.0 Procedure

- 4.1 Positive (known bloodstain) and negative control samples are processed, prior to testing any forensic samples (on the day of testing), to ensure the working stock reagents are functioning properly.
- 4.2 Cotton swabs or a folded piece of filter paper are used to collect the suspected blood onto the tip. A swab may be moistened with sterile/nanopure  $H_2O$  if necessary.
- 4.3 To the swab or filter paper with the suspected blood, add 1-2 drops of o-tolidine working solution. Wait 10-15 seconds to detect potential false positives.
- 4.4 Add 1-2 drops of 3% H<sub>2</sub>O<sub>2</sub> and note appearance or absence of blue-green color.

Optimum visualization of physiological fluids and fibers is typically achieved at ~450nm and ~485nm, respectively; however, it is often necessary to test each of the wavelengths (450nm - 540nm) and choose the most appropriate based on the background fluorescence encountered with the particular substrate. ### 1.0 Background/References

- 1.1 The identification of semen is a multi-step process for which it is necessary to generate extracts of putative semen stains for use in the identification tests.
- 2.0 Scope
  - 2.1 To provide a method of generating suitable extracts from evidentiary material for orensic the performance of both presumptive (as needed) and confirmatory testing for the presence of semen, as well as other forensic analyses.

### 3.0 Equipment/Reagents

- Small (e.g., 12x75mm) tubes or 1.5/0.5ml microfuge tubes
- Pipette(s) and filter barrier tips

4.0 Procedure

- 4.1 Label tubes with identifying information.
- 4.2 Take a sample ( $\sim$ 2-5 mm<sup>2</sup> portion of stain or  $\sim$ 1/8 each of one or two cotton swabs), transfer to the appropriately labeled tube and extract in a minimal volume (50-100µl) of  $dH_2O$  at RT for  $\geq 20$  minutes.
- 4.3 At this point, agitation, vortexing, brief sonication and/or piggyback centrifugation may be used to assist in removing sperm/cellular material from the substrate.
- 4.4 Mix/resuspend the sample for use in microscopic examination (BI-118) and/or p30 detection (BI-120). Alternatively, the supernatant may be removed, without disturbing the pellet, for additional testing [e.g. AP screening (BI-114), p30, etc.] prior to resuspension.

### 5.0 Comments

- 5.1 Other reagents may be substituted for  $dH_2O$  (e.g., 1XPBS, PCR-TE, saline) in 4.2.
- 5.2 The sample sizes and extraction volumes are those typically used and are recommendations. The scientist has the discretion to increase or decrease the sample size and corresponding extraction volume as case circumstances dictate.
- 5.3 While the primary use of this liquid extract is for semen identification testing, these extracts may be used for other screening tests as well (e.g., saliva, urine, feces).
- 5.4 The sample may optionally be extracted in dH20 directly on the microscope slide at the analyst's discretion. However, the quantity of sperm observed may be diminished and no sample will remain for further testing (e.g. p30) when using this method.

The scientist may also note e-cell descriptions [e.g. nucleated (NEC or nuc.) or anucleated (ANEC or A-nuc.)] and whether or not there are large squamous epithelial cells present.
  - 4.7.4 If the situation arises in which there are only one to three sperm heads, a single intact sperm, or a few sperm heads of questionable morphology, a photograph of at least one sperm shall be taken and included in the note packet (see BI-119).
  - 4.7.5 For ease of re-location, the position of sperm in cases where 3 or less have been identified may be documented in the case notes.

- 5.3 Both positive (known semen stain extract or Seri<sup>™</sup> semen standard [10ng; 10µl of a 1:100 dilution]) and negative (extraction buffer alone) controls are used in the event the test has not been performed in the laboratory in a six month period.
- 5.4 Since the reaction time is dependent on p30 concentration, as well as other samplespecific factors, it is necessary to wait the full 10-minute incubation before reporting a negative result. However, a positive reaction may occur in much less time.
- 5.5 As with any antigen/antibody interaction, excess antigen may lead to a 'high dose hook effect' resulting in false negatives when the p30 concentration is very high. This effect should be considered when examination and presumptive tests have indicated the likelihood of the presence of semen. In those instances, the sample

# Amylase Test (Phadebas) (BI-122)

## 4.0 Procedure

NOTE: All orifice swabs, and body swabs suspected of containing a body fluid (or as appropriate per case scenario), from sexual assault kits with a female victim and male suspect(s) will be screened for the presence of male DNA utilizing this method. Traditional serological testing for detection of specific biological fluids will only be performed in such cases upon request from the prosecuting or defense attorney, or upon receipt of a court order.

## 4.1 LYSATE PREPARATION:

No more than four  $\sim 1/8$  swab cuttings should be cut into a single tube. If a sub-item consists of more than four swabs from a single location the cuttings should be split into an additional tube(s). If an additional tube(s) is required a designator will be used to distinguish between the samples with the tubes and swab sticks being labeled accordingly (i.e. 1.2A/1.2B or 1.2-1/1.2-2). If the sub-item consists of fewer than four total swabs a slightly larger cutting may be taken from each swab as long the total amount of swab material in a single tube does not exceed  $\sim 1/2$  swab when added together (i.e. if there are three swabs up to an  $\sim 1/6$  cutting may be taken from each). NOTE: It is assumed that the swabs comprising a sub-item from a single location were collected in a uniform manner with an approximate even distribution of biological material.
- 4.1.2 For each sub-item in the sexual assault kit that consists of orifice or body swabs from the same location, not suspected to contain semen, it is generally recommended to cut the equivalent of ~1 swab into a single 1.5ml microcentrifuge tube (i.e. ~1/2 of two swabs, ~1/4 of four swabs, etc.). 4.1.1 cutting sizes may also be followed for these samples if needed.
- 4.1.3 Add the following to each tube:

5.1 The "IPC Status" and "Curves Status" flags in the Plexor® Analysis software are important quality indicators. Results indicating very low levels of male DNA (i.e. <0.001ng/µl) should be interpreted with extra caution and these quality indicators should be carefully inspected. A very low level male DNA quantitation result associated with a "Check Melts" flag may be due to non-specific amplification or very low levels of true male DNA. Due to the lysates being the result of a "crude lysis" procedure without subsequent purification of the DNA it is possible that inhibition may be observed more frequently than for purified DNA extracts. The AmpSolution™ Reagent optimizes the reaction to help overcome the effects of the "crude lysis" procedure but it is still important to carefully evaluate the IPC results. The melt curve is the best way to assess whether or not a very low level quantitation result is actually DNA signal.</p>

- 5.2 The screening analyst will forward portions of samples on for DNA analysis where male DNA was detected or with an "inconclusive" result, based upon case circumstances, orifice or body swab location, and/or quantitation results. Typically if the Auto:Y ratio is 250 or greater, and the sample is not suspected to contain semen such that a differential extraction would not be performed, the screening analyst will not forward the sample for subsequent STR analysis.
- 5.3 The screening analyst will indicate in the case notes whether or not semen is suspected for all sub-items with a positive or "inconclusive" result for male DNA in order to provide guidance to the analyst and technical reviewer as to whether or not a differential extraction may need to be performed. The determination as to whether or not semen is suspected will be based upon case circumstances, orifice or body swab location, and/or quantitation results. If there is insufficient information available to assist in this determination the screening analyst may elect to perform presumptive testing for acid phosphatase to aid in the determination. The results of any such acid phosphatase testing are required to be included in the final case report.
- 5.4 The Auto:Y ratio and/or quantity of male DNA detected during the quantitation of the "crude lysate" may not be fully representative of the results expected from a purified DNA extract that would be generated during STR DNA analysis when a differential extraction is to be performed. Therefore, obtaining a high Auto:Y ratio result from the "crude lysate" will not always be reason to forego subsequent STR DNA analysis.
- 5.5 The whole swab crude lysates for non-semen containing samples should be purified on the EZ1 rather than taking additional sample cuttings for extraction. A corresponding reagent blank will need to be purified; therefore, it may be advisable to include an additional reagent blank with Y-Screen batches. If crude lysates are to be purified on the EZ1, they should be stored refrigerated (short term) or frozen (long term). If EZ1 purification is to be performed, transfer the lysate to an EZ1 sample tube and proceed to step 4.8 of BI-200.
- 5.6 Orifice swabs contained in the kit that have no male DNA detected during the yscreen process may be used as a victim reference sample if a blood card/liquid blood was not provided. This includes oral, anal, and vaginal swabs.

- 4.3.2 Once a suitable hair(s), preferably anagen, has been identified it may be washed to reduce surface dirt and contaminants. This may be accomplished by immersing the hair(s) in sterile, deionized water and gently swirling. Each hair to be analyzed should be washed separately in fresh water. Alternatively, the hair(s) may be placed in a 1.5ml tube containing 1ml 10% SDS and sonicated briefly. Again, each hair to be analyzed should be treated separately. If the presence of any body fluid is noted on the hair shaft, it may be removed for separate DNA analysis, if necessary, by soaking the hair in a minimal amount of sterile deionized water or PCR TE for 30 minutes. Process this extract as you would a bloodstain (see 4.2.1).

- 4.6.14 When the protocol ends, the LCD displays "Protocol finished." To run another protocol, press "ESC" to return to the protocols menu. Otherwise, press "Stop" twice to return to the first screen of the LCD.
- 4.6.15 Open the workstation door. Remove and cap the elution tubes containing the purified DNA. Discard the cartridges, tip holders/tips, and sample tubes.
- 4.6.16 At the completion of all runs for the day, clean the piercing tool (option #3 from the 'man(ual)' screen) O-rings and tip adaptor, tip rack, cartridge rack, and interior of the instrument with 70% Ethanol, followed, optionally, by nanopure water.
- 4.6.17 Switch off the instrument, leaving the Investigator card in place.
- 4.6.18 Proceed to real time PCR (see BI-207) for quantitation of the purified DNA sicse obtained in step 4.6.15.
- 4.7 REMOVING MATERIAL FROM SLIDES:

- 4.8.2 Following DNA testing, any leftover DNA extracts will be put into a plastic zip bag and/or coin envelope and given a new item number in ILIMS. An ILIMS barcode will be printed and placed on the envelope containing the extracts. Individual tubes may also be sealed with parafilm or other sealant to prevent leakage and/or evaporation if desired. DNA extracts will be stored in the laboratory evidence freezer at approximately -20°C pending return to the submitting agency. Additionally, a 'store frozen' sticker should be placed on the outside of the envelope containing DNA extracts prior to returning them to the agency.
- 5.0 Comments
  - 5.1 An appropriate reagent blank (for each type of extraction) will be carried through all extraction steps to check the purity of the reagents being used. Questioned and known extraction batches will require separate reagent blanks. It is not necessary to have a separate blank for each case that is extracted at the same time; however for a batch of samples (>1 sample), two reagent blanks should be created, in which the same lots of reagents are used. When extracting a batch of samples with multiple EZ1 Robots, a single set of reagent blanks may be used, providing the instruments are running concurrently. Additional reagent blanks will be incorporated when the sample number exceeds the capacity of available instruments (requiring subsequent runs), so that one set of blanks is included with each run.
  - 5.2 Presoaking bloodstains with PBS may help to prevent inhibition of amplification by heme products, particularly when analyzing DNA obtained from samples of "heavy" bloodstains (e.g. control bloodstains).
  - 5.3 These procedures represent the 'usual' protocol for a given material; however, any of these different extraction methods are suitable for all biological materials, though minor modifications may be necessary.
- 5.4 Extracts may be re-purified on the EZ1 if needed (i.e.: Inhibition indicated at quantification or data analysis). A corresponding reagent blank would need to be purified as well. Refer to above step 4.6 of BI-200.

4.0 Procedure

- 4.1.4 Prepare Std. 3-7 via a serial dilution by mixing and subsequent 10µl transfers starting with tube B and ending with G. The dilution series consists of 50, 10, 2, 0.4, 0.08, 0.016, 0.0032ng/µl (or adjusted per kit QC), and a no-template control, respectively.
- 4.2 REACTION PREPARATION:
  - 4.2.1 Determine the number of samples to be quantitated (including, at minimum, 2 sets of DNA standards).
  - 4.2.2 Fill out the 7500 Load Sheet on the Casework worksheets template (Form 206-BI) or electronic equivalent in ILIMS. Print a copy for the case file if applicable.

- 4.3.4 In the SDS software, log in as "Guest". Select "Template" from the home screen and chose "PlexorHY". Under Experiment Properties, name the plate in the Experiment Name field. Other required settings should be as follows: Which Instrument: 7500 (96 wells), Type of experiment: Quantitation Standard Curve, Reagents: Other, ensure "Include Melt Curve" is checked, and Ramp speed: Standard (~2 hours to complete a run).
- 4.3.5 In the Plate Setup screen, select the "Assign Targets and Samples" tab. Highlight the wells that contain samples or standards and apply the autosomal, Y, IPC, and passive reference detectors. Do not include any unused wells. It is not necessary to name the samples but may be done if desired.

- 4.4.9 Highlight the standard wells and click the 'Create Dilution Series' icon in the tool bar. Select 'vertical series' and 'decreasing'. Enter 50 (or adjusted value from the kit QC) as the starting concentration and 5 as the dilution factor. Click 'apply'.
- 4.4.10 Leave the standard wells highlighted and in the melt curves window, drag the target melt temperature line to the midpoint of the melt curves. Do this for the autosomal, Y, and IPC curves. The melt temperature (Tm) for each sample will be displayed in the table on the right.
  - A 'yes' or 'no' in the Tm column indicates whether a sample has a melt temperature within the target range. A 'no call' indicates that the sample has a melt curve within the range but there is insufficient sample to cross the threshold. An increase in the Tm for unknowns may indicate the presence of impurities.
- 4.4.11 With the standard wells still highlighted, select the autosomal channel and click the 'Add Standard Curve' icon in the tool bar. Repeat for the Y channel. Select the 'Standard Curves' tab to view the standard curves. Review the autosomal and Y data for inconsistencies from the following:
  - An R<sup>2</sup> value of ≥0.990 indicates a close fit between the standard curve regression line and the individual CT data points of quantification standard reactions.
  - An R<sup>2</sup> value of <0.99 may be due to variability of the 0.0032ng/µl dilution. These may be omitted as necessary. If the R<sup>2</sup> value does not improve with removal of these standards, the Plexor HY System Technical Manual (section 7) may be referred to for troubleshooting guidelines. At least one of each of the other standards must be present.
  - The slope should fall within the typical slope range of -3.2 to -4.0 for the autosomal target and -3.0 to -3.6 for the Y target. A slope of -3.3 indicates 100% amplification efficiency.

5.0 Comments

- 5.1 After initial thawing, the Plexor HY Male Genomic DNA Standard will be stored at approximately 4°C.
- 5.2 DNA standards may be prepared using different volumes as long as the ratios are the same.
- 5.3 Refer to the Plexor HY System Technical Manual for additional user information and troubleshooting guidelines.

- 5.5 The Halogen Lamp may be checked manually to determine if replacement is needed. Place the Green Calibration Tray in the block. - 4.1 DNA TEMPLATE:
  - 4.1.1 Based upon the quantity of DNA isolated and its initial concentration, the scientist should have all samples at an optimal concentration for amplification (e.g., 0.1 ng/µl-0.2 ng/µl). It is also convenient to have all samples that are to be amplified at the same time to be at the same concentration if possible for ease in the preparation of PCR Master Mix and reaction additions. The maximum amplification volume for low level or undetected samples is 15µl for PowerPlex Fusion 6C. For such samples, it may be appropriate to concentrate the sample prior to amplification using the DNA SpeedVac. The analyst may also choose to extract, quantitate, and combine additional sample prior to amplification as an alternative.

Note: If a sample is concentrated using the DNA SpeedVac, an equivalent volume of a corresponding reagent blank shall be similarly concentrated. For this reason it is advisable to include an additional reagent blank if it is suspected that DNA SpeedVac concentration will be performed.

- 4.1.2 The amount of DNA template added to an amplification reaction should be targeted at  $\sim$ 1.0-2.0ng but may be adjusted if necessary.
- 4.2 AMPLIFICATION SET-UP:
  - 4.2.1 Determine the number of samples to be amplified.
  - 4.2.2 Thaw the PowerPlex Fusion 6C 5X Master Mix, PowerPlex Fusion 6C 5X Primer Pair Mix, and Amplification Grade Water (optional).
  - 4.2.3 Calculate the volume of reaction components needed based upon the number of samples (including extraction and amplification controls) to be amplified and adding additional reactions to compensate for loss and variability due to pipetting. Use 'Amp Worksheet' tab of the Fusion 6C Casework DNA Worksheets (Form 206-BI) or electronic equivalent in ILIMS to record thermal cycler positions and to automatically calculate necessary volumes. - 4.2.5 Pipette the appropriate amount of reaction mix into each well of a 96 well plate or microAmp tube if processing cases individually. The negative amplification control should be the last sample processed.
- 4.2.6 If DNA concentrations were not the same, add appropriate volume of  $dH_2O$  as necessary.
- 4.2.7 Pipette each DNA sample into the appropriate well. Place strip caps on each column of samples following addition of all samples to that column. When using microAmp tubes, only the tube to which the DNA is being added should be opened at this time and only one DNA-containing tube should be open at any time. Use 2800M control DNA for the positive amplification control and dH2O or PCR-TE for the negative amplification control. Again, making additions to the negative control last.

#### **4.5 AMPLIFIED DNA PRODUCT:**

#### 1.0 Background/References

1.1 Any eukaryotic genome is interspersed with repeated DNA sequences that are typically classified by the length of the core repeat sequence, and the range of contiguous repeats typically seen or the overall length of the repeat region. STR (Short Tandem Repeat) loci are scattered throughout the genome occurring every 10,000 nucleotides or so, and have core repeat units of 2-6 base pairs (bp) in length with overall lengths of less than 400 bp.

STR loci examined for human identification purposes were selected for the following characteristics: 1) high discriminating power (generally >0.9) with observed heterozygosity of >70%, 2) loci on separate chromosomes to avoid linkage, 3) ability to obtain robust, quality, reproducible data when multiplex amplification is performed, 4) low stutter, 5) low mutation rate and 6) small allele sizes (<500 bp) for enhancement of analysis of degraded samples.

By 1997, as the result of a community-wide forensic science effort, the following 13 STR loci, all tetranucleotide repeats, were selected as the basis for NDIS, the CODIS (COmbined DNA Index System) National Database: D3S1358, TH01, D21S11, D18S51, D5S818, D13S317, D7S820, D16S539, CSF1PO, vWA, D8S1179, TPOX, FGA. When all 13 CODIS core loci were examined, the average random match probability was found to be <1 in  $1 \times 10^{12}$  among unrelated individuals, offering the promise of individualization. In 2017 the CODIS core loci expand from 13 to 20 with the addition of: D1S1656, D2S441, D10S1248, D2S1338, D12S391, D19S433, and D22S1045.

In addition to the 20 core CODIS loci, the PowerPlex Fusion 6C multiplex includes a gender identification locus (Amelogenin), Y-STR loci (DYS391, DYS576, and DYS570), two pentanucleotide repeat STR loci (Penta D and Penta E), and SE33. STR typing (with amplified products generated from this kit, separated by capillary electrophoresis on the 3500 Genetic Analyzer using data collection and analysis software employed in developing the genetic profiles) will be used to produce STR profiles from evidentiary material for case comparisons and applicable entry into CODIS.

  - 4.1.4.2 The 6C Matrix Mix is diluted by adding 10µl to one tube of Matrix Dilution Buffer. 10µl of the diluted 6C Matrix Mix is then added to 500µl of deionized formamide (without size standard). Load 15µl of the 6C Matrix Mix with formamide into each of eight wells on the pre-labeled plate, which will include each of the eight capillaries (e.g. wells A1 through H1). Note: At the first use, thaw the 6C Matrix Mix and Matrix Dilution Buffer completely. After the first use, store the reagents at 2-10°C, protected from light. The diluted 6C Matrix Mix can be stored for up to 1 week at 2-10°C.

- 4.1.5 Following sample addition, place a plate septa on the plate. The plate septa may be cut to cover only those well columns being used on smaller plate runs. Note:
  Optional heat denature for ~3 minutes at 95°C for amplified product ONLY. Do not heat denature the matrix standard.
- 4.1.6 Place the sample plate into the plate base and secure the plate retainer clip on top, making sure that no gray is visible through the holes.
- 4.1.7 Place the plate assembly in the instrument and close the doors. From the Assign Plates for Run screen, click Link Plate for Run.
- 4.1.8 Verify the correct scheduling of the run in the 'Preview Run' screen. Select a run and confirm that the corresponding wells highlighted in the plate diagram are correct for that run. Make adjustments to the plate record if necessary.

4.1.9 Click Start Run. Monitor electrophoresis in the Monitor Run screen. Each injection (set of eight samples) will take ~40 minutes.

4.1.10 After completion of the spectral calibration run, evaluate the spectral and set the active calibration. Confirm that Dye Set J6 is selected. Click on individual wells in the plate diagram to see results for each of the eight capillaries. For each capillary, verify that six peaks are present in the spectral profile (lower pane), that the order of the peaks are, from left to right, blue-green-yellow-red-purpleorange, and that the peaks are regular in appearance. Next verify that six peaks are present in the raw data profile (upper pane), that the order of the peaks are, from left to right, orange-red-yellow-green-blue-purple.

Note: One adjacent-capillary borrowing event is allowed for an 8-capillary instrument. A passing capillary will be colored green in the plate diagram, borrowed will be yellow.

Rerun the spectral calibration as necessary until a passing spectral run is achieved.

- 4.2 DATA ANALYSIS: GENEMAPPER<sup>®</sup> IDX (GMIDX)
- 4.2.1 Data analysis is NOT performed on the instrument computers. Transfer the run folder (including the sample sheet) to an analysis computer using a portable USB drive. After analysis and review are complete, a copy of the run folder and GMIDX project will be stored on the ISPFS network drive. The Run Folder on the instrument computer may be deleted at this point. Case-specific CDs will be made for discovery upon request.

Note: prior to data analysis, the appropriate panels and bins must be imported into GeneMapper<sup>®</sup> IDX. Additionally, previously run 310 Macintosh data must first be converted to PC files using the 'Mac to Win' conversion program.

4.2.2 Set up the analysis methods for GMIDX analysis as follows (analysis methods are created and stored in the 'Analysis Methods' tab in 'GeneMapper Manager'):

- 'General' Tab: Name the analysis method so that it reflects what the method is [e.g. Fusion6C CW Direct Amp].
- 'Allele' Tab: Choose the appropriate bin set. For extracted samples, choose 'Use marker-specific stutter ratio and distance if available'. All values should be 0. Note: questioned samples should be exported for STRmix without the stutter filters applied. For direct amplification samples, choose 'Use marker-specific stutter ratio and distance if available'. 'Global Cut-off Value' should be 0.2, 'Global Minus Stutter Distance' should be from 3.25 to 4.75 for the Tetra marker repeat type.
- 'Peak Detector' Tab: Advanced Peak Detection Algorithm, light smoothing, Local Southern size calling method with baseline window of 51 pts, min. peak half width = 2, polynomial degree = 3, peak window size = 15, and slope thresholds = 0.
  - Analysis range may be set to either full or partial and is empirically determined for each run and/or instrument. When using partial range, the start and stop points are determined by a review of the raw data and choosing points that will not include the primer peaks but will cover the size range of 60 to ≥500 bases.
  - Peak Amplitude Threshold was empirically established as 70 RFU in all colors for extracted samples, 75 RFU in all colors for direct amplification samples. Peaks below these thresholds are deemed inconclusive for their respective sample types.
- 'Peak Quality' Tab: The minimum peak height ratio for Heterozygote Balance should be set at 0.7. Set the max peak width to 1.5 bp and pull-up ratio to 0.05. For extracted samples, the signal level minimum peak heights should be set to 400.0 (3500) or 700.0 (3500XL) for Homozygous, 70.0 for Heterozygous. For direct amplification samples, the signal level minimum peak heights should be set to 250.0 for Homozygous, 75.0 for Heterozygous. Allele number may be set according to analyst preference and sample type.

'Quality Flags' Tab: The quality flags are only used as a tool to aid in data analysis and review (i.e. to assist in calling attention to potential artifacts or data quality concerns). These flag settings may be adjusted according to analyst preference and sample quality.

4.2.3 Create and store a size standard for GMIDX analysis, under the 'Size Standards' tab in 'GeneMapper Manager'. Name the size standard so that it reflects what the standard is [e.g. WEN\_ILS500 (60-500)].

Data analysis will be performed using the 'Basic or Advanced' size standard. The size standard consists of the following peaks: 60, 65, 80, 100, 120, 140, 160, 180, 200, 225, 250, 275, 300, 325, 350, 375, 400, 425, 450, 475, and 500.

- 4.2.4 Create a GeneMapper<sup>®</sup> IDX Project:
  - 4.2.4.1 From the GMIDX main menu, select File/Add Samples to project. Highlight the appropriate run folder in the pop-up window and click 'Add to List'. Once the run folder has been copied to the column on the right, click 'Add' to populate the project with the samples in the run folder.
  - 4.2.4.2 In the Samples table, for each sample, select the sample type, analysis method, panel, and size standard from the pull-down lists if not auto-populated based on the 3500 import file. Ladders must be assigned the sample type of 'Allelic Ladder' for the analysis to occur. In order to use the control concordance quality flag, all controls must be marked appropriately as either 'Positive Control', or 'Negative Control'. All others may be marked as 'Sample'.
  - 4.2.4.3 Save the project as the batch # (and any other descriptors that may be necessary). Optionally, samples may be added to the project individually, rather than the entire run folder. Note: the analyzed project will be exported to the batch folder at the completion of analysis.
  - 4.2.4.4 Analyze the samples by clicking the green Analyze button. If the project has not already been saved, a prompt will appear to enter a project name before analysis will commence.
- 4.2.5 Evaluate GeneMapper<sup>®</sup> IDX Data:
  - 4.2.5.1 The Raw Data may be reviewed to determine analysis start/stop points, or to identify baseline problems, off-scale data, excessive 'spikes' or other anomalies that may interfere with data analysis and require re-injection or other corrective measures. Expand the run folder located in the navigation pane on the left. Highlight the sample(s) of interest to view the associated sample information, raw data and EPT data. Minimize or highlight the run folder to return to the main project window.
  - 4.2.5.2 Check the 'SQ' (sizing quality) for all samples. A green square indicates that the sample has passed the sizing criteria and need not be manually examined. Examine the size standard of each sample with yellow and/or red 'SQ' to confirm correct assignment of fragment sizes. Highlight the sample(s) of interest and click the Size Match Editor button. If necessary, adjust the peak assignments by right clicking on a peak and deleting, adding, and/or changing values. If all peaks are correctly labeled but the quality score is below 1.0 (may be checked by choosing Tools/Check Sizing Quality), click the 'Override SQ' button to set the SQ to 1.0, if desired. Once all edits have been made, click 'OK' to save the changes and close the Size Match Editor (clicking 'Apply' saves the changes but leaves the Size Match Editor open). These samples are ready for reanalysis in the project window.

4.2.5.3 Examine the blue, green, yellow, red, and purple allelic ladders. Check that correct allelic assignments were made.

Note: GMIDX automatically averages all valid ladders in a run for genotyping. Genotypes are assigned by comparing the sizing of unknown alleles from samples with the sizing of known alleles contained within the averaged allelic ladders of each locus. A ladder(s) may be omitted from analysis by deleting it from the main project window prior to analysis or by changing its sample type to "Sample".

- 4.2.5.4 Data may be examined in various combinations of colors and/or tables to identify bleed-through, spikes, stutter, -A, off-ladder variants, etc. Sample Plots viewed from the 'Samples' tab/window, allows all loci in a given color(s) to be viewed simultaneously. The Sample Plots view from the 'Genotypes' tab/window; however, allows loci to be viewed individually (more than one locus can be viewed at the same time by adjusting the number of panes displayed).
- 4.2.5.5 GeneMapper<sup>®</sup> IDX includes a series of quality flags (PQVs) to alert the analyst of potential sample quality concerns. A green square indicates that sample data has passed all of the quality checks, but yellow or red indicate that the data has a problem with one or more of the quality checks. A yellow or red flag does not necessarily mean that the data is bad or unusable and the flags are not to be relied on solely. The analyst may choose to use the PQVs, in combination with manual data examination to aid in the identification of bleed-through, spikes, stutter, off-ladder variants, -A, etc. Once the data has been evaluated and deemed acceptable, the analyst may choose to override the yellow or red Genotype Quality (GQ) flag by right clicking on the flag in the Genotypes Sample Plots view. Note: overriding the GQ flag will cause all other flags to turn from the original color to gray.
- 4.2.5.6 All negative controls (including reagent blanks) should be examined to verify that each displays a relatively flat baseline in blue, green, yellow, red, and purple.
- 4.2.5.7 Review all samples (including positive controls) for the above listed 'artifacts' and evaluate: peak height and shape, matrix/spectral quality, and individual sample profiles. Compare each sample with the allelic ladder(s) and examine for off-ladder or microvariants, signals that were too low to be genotyped and assignment of genotypes to stutter peaks (or minor peaks that may have been subtracted as 'stutter', etc).

- 4.2.5.8 Edit peaks as necessary, by right clicking on the peak label and selecting 'add allele', 'delete allele' or 'rename allele'. The allele should be labeled, at minimum with the allele call, however the analyst may select up to four allele labels, including peak height and size, from the 'Plot Settings Editor' window. Note: labels added to artifact peaks, such as spike, pull-up, etc. will appear in the Genotypes table as an additional allele.
- 4.2.5.9 Samples demonstrating an off-ladder (< or > smallest or largest ladder allele, respectively), tri-allele, or microvariant (alleles with incomplete repeats) allele(s) should be re-analyzed for verification where necessary (e.g., evidentiary profile in no-suspect case). Microvariants will be labeled and reported as "X.Y" (where X is the number of complete repeats and Y is the number of base pairs of the incomplete repeat). Off-ladder will be reported as > or < the largest or smallest ladder allele, respectively. Note: the nomenclature for upload to NDIS may necessitate a change in allele designation. STRmix requires only numeric values and off-ladder alleles reported as > or < should be assigned the numeric value for the actual extrapolated allele call (e.g., 26 instead of >25) prior to export.
- 4.2.5.10 GMIDX automatically flags off-scale (camera saturation) data. This data may still be acceptable if it is limited to a few or a single peak and the overall data for that sample is of good quality.
- 4.2.5.11 An allele/genotypes table should be exported as a text file for import into ILIMS. The table may also be exported as a .cmf file for CODIS import. To create a .cmf file, the specimen category must be assigned and the export fields set in the 'CODIS Export Manager' under tools in the main menu. Tables for STRmix<sup>™</sup> should be exported as text files for questioned (allele, size, height) and knowns (allele, size) with 12 alleles per locus.
- 4.2.5.12 'Samples Plots', consisting of only the individual case samples, will be printed as pdf for case notes. It is not necessary to include the internal lane standard dye channel.

## 5.0 Comments

- 5.1 The 3500 Data Collection Software does not allow the entry of spaces in titles, sample names, etc. An alternative character (e.g., underscore or dash) must be used in place of spaces when entering information.
- 5.2 If data is rejected and will not be used for reporting purposes, a note will be made in the associated worksheets/case file. If a reinjection is performed after data analysis, a re-setup of the CE plate is made, or a re-amplification is performed, notes will be made accordingly to indicate the rework performed. The new data will be reported unless otherwise noted in the case file. A sample set up for multiple injections upfront does not constitute rework.

5.3 If an unresolved peak is observed, a note should be made on the electropherogram after printing as to the allele call, approximate size and height. This locus may need to be ignored for interpretation.

# STR Interpretation Guidelines and Statistical Analyses (BI-212)

## 1.0 Background/References

1.1 Following generation of an STR profile the results must be interpreted by a forensic scientist. This analytical method provides general interpretation guidelines for interpreting samples in forensic DNA casework. These guidelines are designed in order to ensure that conclusions are supported by reliable data, derived using a scientific approach, are objective, and consistent from one analyst to another. The interpretation of DNA results should take into account the DNA results obtained, the nature of the sample, the condition of the profile, any forensically valid assumptions made, and should be scientifically justifiable and based on the collected experience and knowledge of the laboratory and the scientific community. These guidelines are designed to provide a general foundation for interpretation but may not account for all scenarios that will be encountered. In those scenarios the forensic scientist and DNA technical lead will determine the course of action that is scientifically most appropriate.

Software programs are available to the forensic scientist as tools to aide in their interpretation. STRmix<sup>™</sup> is a software program that applies a fully continuous approach to DNA profile interpretation. It standardizes the analysis of profiles in the laboratory by using estimates of variance of results derived from validation data. DNA analysis is a comparative test and STRmix<sup>™</sup> provides statistical weight to comparisons by calculating Likelihood Ratios (LRs). The PopStats software from the FBI is used for statistical calculations in paternity/kinship cases.

As part of the interpretation and write up process, analyst will ensure CODIS profiles meet eligibility requirements as defined by the FBI.

- 4.1.1 The purpose of a REAGENT BLANK (RB) is to determine if the reagents used for DNA extraction/isolation were contaminated with human DNA and as a method for monitoring facility decontamination. In GeneMapper<sup>®</sup> IDX, peaks above threshold should only appear in the WEN (orange dye) lane, corresponding to the WEN ILS500 size standard. Electropherograms for the blue, green, yellow, red, and purple dyes should show a relatively flat baseline throughout the range (discounting primer signal, fluorescent 'spikes' or WEN bleed-through). If detectable signal, with characteristic 'peak' shape is visible in the electropherogram of a reagent blank and does not disappear upon re-injection, results for all associated samples may be deemed inconclusive (close examination at 70 RFU is performed on all samples to examine for presence of any alleles seen in the RB). Data may be deemed acceptable if contamination is 'isolated' to the RB. The reagent blank should be treated the same as the least concentrated DNA sample within the associated batch, in terms of volume and amount amplified, injection time/amount, and analysis threshold. If more than one reagent blank is processed with a batch of samples, the blank with the highest signal detected at quantitation (if applicable) will be amplified. The remaining blank(s) need not be carried through. Additionally, the reagent blank will be reamplified with samples from the set if any of the amplification conditions are more sensitive than the original.
  - 4.1.2 The purpose of the POSITIVE AMPLIFICATION CONTROL (2800M DNA supplied with the Fusion 6C kit) is to assess the amplification process, ensuring that adequate sample amplified simultaneously would produce an appropriate signal. All expected alleles (see below) must be detected, using standard parameters or all of the samples associated with amplification may be deemed inconclusive. Data may be deemed acceptable if all alleles are present [though some (generally 4 or fewer) are below analytical threshold] AND relative peak heights of all other samples appear as expected (i.e. the problem is confined to the 2800M sample).

4.1.3 The purpose of the NEGATIVE AMPLIFICATION CONTROL is to determine if any human DNA contamination occurred in the process of amplification set-up (or beyond that point) and as another method of monitoring facility decontamination. In the GeneMapper<sup>®</sup> IDX electropherograms, peaks above threshold should only appear in the WEN (orange dye) lane, corresponding to the WEN ILS500 size standard. Electropherograms for the blue, green, yellow, red, and purple dyes should show a relatively flat baseline throughout the range (discounting primer signal, fluorescent 'spikes' or WEN bleed-through). If detectable signal, with characteristic 'peak' shape, is visible in the electropherogram of a negative amplification control and does not disappear upon re-injection, results for all of the same peak(s). The negative amplification control should be treated the same as the positive amplification control within the associated batch, in terms of volume and amount amplified, injection time/amount, and analysis threshold.

If extraneous peaks appear only in this control, the data for other samples associated with that amplification need not be deemed inconclusive. This occurrence should be documented and the scientist's determination (and basis for it) documented in the case file.

4.1.4 After evaluation of the data, the Profile Comparison tool in GMIDX may be used to assist with contamination evaluation. From the GMIDX main screen, select Tools > Profile Comparison.

4.1.4.1. Export the Sample Concordance tab results.

4.1.4.2. Select the Sample Comparison tab and "Compare Profiles" at 80% Match Threshold. Export the results. If there are no profiles that meet the 80% threshold, a popup will occur that states "No matches found that meet the selected percent match threshold" after the "Compare Profiles" button is selected. If this occurs, a screenshot may be taken (be sure to include the plate name!) to show the comparisons were attempted. Note: The popup that states "There is no data to export" does not indicate that the comparisons were attempted and therefore should not be included.

**4.1.4.3**. Evaluate the exported comparisons for potential contamination. **4.2** RFU THRESHOLD:

4.2.1 An analytical threshold of 70 RFU will be used for data analysis of all extracted samples, 75 RFU for direct amplification samples. The stochastic threshold was determined to be 400 RFU (3500) or 700 RFU (3500XL) for extracted samples and 250 RFU for direct amplification samples. If necessary, go back in the process as follows: repeat injection, perform re-analysis (i.e., changing amount of amplified product added for fragment analysis), re-amplification (increase DNA template), or re-extraction.

- 4.2.2 Peaks below the analysis threshold (based on data obtained and signal/baseline) will not be interpreted.
- 4.2.3 Peaks marked as off-scale in GeneMapper<sup>®</sup> IDX (indicating camera saturation) will not be interpreted if multiple peaks are affected and if it causes excessive artifacts (i.e. split peaks, increased stutter, pull-up, etc.) which interfere with data interpretation. If the overall quality of the data is not acceptable, the sample must be diluted, reinjected, reanalyzed (decrease the amount of amplified product added) or reamplified (decrease DNA template) as deemed appropriate by the scientist. Note: Peaks that exceed the saturation threshold of 30,000 RFU in STRmix are treated qualitatively.
- 4.2.4 Multiplex amplification kits are designed so that heterozygous loci in single-source samples generally demonstrate relatively balanced peak heights [typically >70% peak height ratio (phr)]. Some samples, although single-source, may at times demonstrate greater imbalance due to degradation, stochastic effects, primer binding site mutations, preferential amplification, etc. Peak height ratios for these loci (<70% phr) will be flagged in GeneMapper<sup>®</sup> IDX.
- 4.3 EXTRA PEAKS (NON-MIXTURES)
  - 4.3.1 PCR amplification of STR loci typically produces a minor product peak one core repeat unit shorter than the main allele peak (n-3 for trinucleotide loci, n-4 for tetranucleotide loci, and n-5 for pentanucleotide loci). This minor peak is referred to as the stutter peak. Percent stutter generally increases with allele length and does not change significantly with the quantity of input DNA (peak heights within ~70-4500 RFU); however, may be increased in low-copy samples. The measurement of percent stutter may be unnaturally high for main peaks that are off-scale or due to problems with spectral performance and can be corrected by diluting (or reamplifying less DNA) the sample and/or applying a new spectral. n+3/n+4/n+5 and n-6/n-8/n-10 stutter may also be seen. Marker specific stutter filters are applied in GeneMapper<sup>®</sup> IDX. Validation data is available to aid in distinguishing between true alleles and stutter peaks. For Fusion 6C, STRmix<sup>™</sup> is able to model -1 repeat stutter (ie: n-4), +1 repeat stutter (ie: n+4), and -2 repeat stutter (ie: n-8) for all STR loci, and -1/2 repeat stutter (n-2) for D1S1656 and SE33.
- **4.3.2** Electronic or fluorescent spikes are random events that produce generally spikeshaped peaks in most or all dye colors at the same location (equivalent bp size) within a single injection. Peak heights usually vary between dye colors for a given spike. These anomalies are generally not reproducible and will typically be eliminated upon reinjection. If the spike is above the analysis threshold and falls within an allelic range that could interfere with either computer analysis or scientist's analysis, the scientist will label the spike in the GeneMapper<sup>®</sup> IDX software so that it appears on the printed electropherograms.

- 4.3.3 Dye "blobs" are anomalies that typically occur in the same approximate location in multiple injections and do not always disappear upon reinjection. Blobs generally look like broad or irregular peaks and may occur in a single color or multiple colors at the same approximate location but can vary in height. The blob should be labeled on the electropherogram (in GMIDX) if it falls within a diagnostic region and is of significant size to potentially interfere with analysis.
- 4.3.4 Bleed-through or pull-up peaks are a result of the spectral not correcting for all of the spectral overlap and may be increased due to off-scale peaks. These pull-up peaks are in the same location (same bp size) as peaks in another color(s) and are easily recognized. The presence of bleed-through should be labeled on the corresponding electropherogram (in GMIDX) if it falls within a diagnostic region and is of significant size to potentially interfere with analysis. If excessive bleed-through occurs in a color other than orange, and is not due to off-scale data, a new spectral may need to be performed.
- 4.3.5 Taq Polymerase can catalyze the addition of a single nucleotide (predominantly adenosine) to the 3' ends of double stranded PCR product, resulting in product one base pair longer than the actual target sequence (+A). Amplification parameters include a final extension time, so that the reaction is driven to full A addition (i.e. all product is +A). Split-peaks may occur as a result of incomplete A addition and appear as a single allele represented by two peaks one base pair apart (-A and +A). This can occur when the amount of template DNA is too great (overloaded sample). In this instance, Taq is unable to add the A nucleotide to the entire amount of product generated in the time allotted. These samples will typically contain off-scale data as well. Split peaks can be alleviated by incubating samples at 60°C for an additional 10 minutes, followed by dilution prior to reinjection. It may be necessary to re-amplify the sample with less template DNA.
  - 4.4.1 If, after the elimination of possible stutter and/or bleed-through, a profile shows at least 3 peaks at 2 or more loci, this is strong evidence of a mixture. A profile showing 3 or more peaks at a single locus and additional peaks below the analysis threshold at other loci is also indicative of a mixture.
  - 4.4.2 Loci that demonstrate only two alleles but have a heterozygous ratio of <70% may also be indicative of a mixture. However, if data are obtained from multiple loci, a scientist should expect to see this or other mixture indications (> 2 alleles) at additional loci.
  - 4.4.3 Mixture assessment, in terms of determining the presence of a mixture (# of potential contributors) is performed prior to examining the reference profiles.

### 4.5 Manual Interpretation

- 4.5.1 Comparison of probative and non-probative (as defined in Biology QA Manual section 10.3.6) reference samples to either a full or partial single source profile (or a fully deduced profile originating from a mixture) may be performed manually. If all of the alleles detected in the questioned sample are also detected in the probative reference sample, peak heights/peak balance conform to expectations, and any missing alleles are reasonably explainable, then the comparison may be deemed a match and a LR statistic will be calculated in STRmix<sup>™</sup>. When the above criteria are met for comparison to a non-probative reference sample a qualitative statement, such as "consistent with", may be used without a supporting statistic. If there are differences in alleles between a questioned sample and a reference sample that are not reasonably explainable, then an exclusionary statement may be used.
- 4.5.2 Mixtures may be interpreted manually in order to determine whether or not a non-probative reference sample is a potential contributor to the mixture. If all of the alleles present in a component of the mixture can be attributed to a non-probative reference sample, peak heights/peak balance conform to expectations for the component, and any missing alleles are reasonably explainable, then a qualitative statement may be used indicating that the non-probative reference sample is a potential contributor to the mixture without a supporting statistic. If all contributors to a mixture have been attributed to non-probative reference samples, then exclusionary statements may be used for probative reference samples without performing STRmix™ analysis.
- 4.5.3 If the complexity of a given profile is such that it is too difficult to interpret manually, then STRmix<sup>™</sup> may be used to aid the interpretation even if it is a profile that is permissible to interpret manually as described above.
- 4.5.4 STRmix<sup>™</sup> analysis may be conditioned upon a reference sample that was manually determined to be a potential contributor to a mixture if conditioning is appropriate.
- 4.5.5 Following deconvolution of a profile in STRmix<sup>™</sup>, if the weighting for a single (fully deconvoluted) genotype is >99% at one or more loci, these loci may be utilized to manually exclude individuals not possessing the >99% genotype(s). If there is only a single locus where this is the case the analyst needs to inspect the data closely similarly to if a single locus yielded a LR of 0 as in step 4.6.2.5.
- 4.5.6 In some circumstances it may be beneficial to make inferences based on evidence to evidence comparisons. In such circumstances, only a qualitative statement (e.g., consistent with) shall be made with respect to reporting the comparison.

- 4.5.7 In cases where a probative single source profile (or a discernable profile originating from a mixture) is developed but a LR would not be calculated due to lack of reference samples for comparison (e.g., unknown suspect, or manual elimination of the available reference samples), the profile may be used for CODIS entry purposes without STRmix<sup>™</sup> deconvolution.
- 4.6 STRmix<sup>™</sup> Analysis
  - 4.6.1 Suitable mixture profiles will be deconvoluted in STRmix<sup>™</sup> prior to making conclusions about comparisons with probative known reference samples.
    Note: Results that are too complex (5 or more contributors) or contain minimal data (typically results at fewer than 6 loci) should not be interpreted.
    - 4.6.1.1 Prior to exporting data from GeneMapper<sup>®</sup> IDX questioned samples need to be exported with stutter filters turned off. Known samples must be exported with stutter filtered. +1 repeat stutter should be left labeled when exporting Fusion or Fusion 6C questioned sample data but should be deleted if exporting PP16 or PP16HS data. All -2 repeat stutter and -1/2 repeat stutter at D1S1656 and SE33 should be left labeled for Fusion 6C data. All other artifacts must be deleted prior to export. Questioned samples must be exported with allele, size, and height. Known samples must be exported with allele and size but may also include height. The export tables will typically contain 12 alleles per locus (if a profile contains more than 12 alleles, including stutter, then the number of alleles will need to be increased in both the export table and STRmix<sup>™</sup> settings).
    - 4.6.1.2 Launch the STRmix<sup>™</sup> software and select "Interpretation" to begin analysis of a sample. Note: "Batch Mode" may be used if multiple samples are to be processed at once.
    - 4.6.1.3 Enter the Case Number and Sample ID.

The Case Notes section may be utilized to document assumptions made; however, entering data into the number of contributors and hypotheses fields is sufficient documentation for these assumptions and comparisons. Assumptions may also, optionally, be documented on the corresponding electropherogram.

**4.6.1.4** Enter the number of contributors to the profile. Note: The number of contributors will be based on the entire profile and will be the number that best explains the data. If the scientist is unable to determine the number of contributors to a profile it may be appropriate to interpret the profile using alternate numbers of contributors (e.g., 3 and 4) and report both statistics. In some scenarios where the number of contributors cannot be confidently determined it may be most appropriate to not interpret the profile.

# MCMC accepts and # burn-in accepts default to 500,000 and 100,000 respectively. Note: Some complex mixtures may benefit from increasing the iteration #s 10-fold. This shall only be done following consultation with the DNA technical lead.

The "Other Settings" button may be used to adjust a default setting only for the run being performed. Any changes will appear in bold in the results. The default settings were determined either empirically via internal validation or are the manufacturer recommendations and shall not be changed without consulting the DNA technical lead with the exception of the "Ignore Loci" button which may occasionally need to be used as in scenarios where a triallelic locus is detected.

Select "Next" to proceed with analysis.

4.6.1.5 Under Evidence Profile Data select "+" and then "Select". Navigate to the table exported from GeneMapper<sup>®</sup> IDX for questioned samples, highlight the appropriate sample, select "Confirm". Note: It is also possible to use a STRmix<sup>™</sup> input file or to create a file for the electropherogram (EPG). See the STRmix<sup>™</sup> Manuals if this is necessary.

At this point a reference EPG will only be added if the interpretation is being conditioned upon the presence of a known contributor or if it is a single source profile and manual comparison has already included an individual. If this is the case a reference EPG can be added following the same method as above. After adding a reference EPG for conditioning, check the "Contributor to: Hd" box in order to assign the contributor to both Hp and Hd. If needed, check the "Perform Database Search" check box. Note: Suitable mixture profiles with an unknown contributor(s) will be compared to the default database which is set as the ISP staff elimination database. Single source profiles only need to be compared against the elimination database if the source is unknown and this comparison may be performed either in STRmix<sup>™</sup> or CODIS. This is a quality assurance measure to check for possible sample contamination. The STRmix<sup>™</sup> search will return candidate matches where the LR exceeds a certain threshold. The default setting for this threshold has been set to 10,000. Ultimately the forensic scientist will assess the search results and determine if contamination is or is not likely.

At this point it is appropriate for the forensic scientist to inspect the report to verify that the analysis is appropriate. Some important aspects to check include: mixture proportions, run information diagnostics, locus efficiencies, and intuitiveness of the weighting. In general, mixture proportions and weighting will be consistent with the expectations of the analyst based on their manual review of the profile. Locus efficiencies are expected to approximately mimic the appearance of the electropherogram. Further information on interpreting run information diagnostics can be found in the STRmix<sup>™</sup> Manuals.

Mixtures assumed to be from two individuals, contributors with less than 70 rfu for the STRmix<sup>™</sup> deconvolution template should be considered trace contributors and not considered for comparisons. For mixtures assumed to be from three or four contributors, contributors with less than 100 rfu for the STRmix<sup>™</sup> deconvolution template should be considered trace contributors and not considered for comparisons. Manual interpretation may be utilized when determining whether to condition on the donor of an intimate body swab prior to deconvolution (For example, a victim may be conditioned on her own vaginal swab without first determining the template amount via STRmix<sup>™</sup> and remain conditioned on if the deconvolution does not meet the guideline template rfu values above). Exceptions to these guidelines may be made after consultation with the technical leader.

Contributor percentage, degradation, total allele count, number of minor contributors, number of obligate alleles, shared mixture proportions, assumed contributors, overall profile quality, and close relatedness of persons of interest (POIs) should all be considered when deeming one or more contributors in a mixture interpretable. If significant ambiguity exists with one or more contributors in a profile, which makes it impossible to intuitively evaluate the STRmix<sup>™</sup> deconvolution or future comparisons, analysts should deem that portion of the profile uninterpretable. If no portion of the data can be evaluated intuitively, the entire profile should be deemed uninterpretable.

4.6.2 Following initial deconvolution of suitable questioned mixture profiles, probative comparisons to known reference samples from POIs will be individually compared to the profile and LRs calculated using the "Investigation" > "LR from Previous" buttons within STRmix™. Note: STRmix™ analysis may not be necessary for comparisons to single source profiles or those deemed nonprobative in accordance with Biology QA Manual section 10.3.6.

Each POI shall be compared separately using the propositions:

Hp: POI and N-1 unknown contributors Hd: N unknown contributors

Where N is the total number of contributors to the profile.

Hp: Known, POI, and N-2 unknown contributors Hd: Known and N-1 unknown contributors

Where known represents contributors whose presence the interpretation is conditioned upon.

If more than one POI results in a LR supporting inclusion, then it may be appropriate to calculate a LR under alternate propositions incorporating multiple POIs. In this scenario the propositions used are:

- 4.6.2.2 In the Sample ID section the item # of the known sample being compared may be added to the end of the questioned item Sample ID. Select "Next".
- 4.6.2.3 Under Reference Profile Data select "+" and then "Add". Navigate to the table exported from GeneMapper<sup>®</sup> IDX for known samples, highlight the appropriate sample, select "Confirm", and select "Add". Note: It is also possible to use a STRmix<sup>™</sup> input file or to create a file for the EPG. See the STRmix<sup>™</sup> Manuals if this is necessary.

- 4.6.2.4 Populations using the NIST allele frequency data from African American, Caucasian, and Hispanic populations will be the default. Theta values of 0.01 are to be used for each population. Additional population data may also be used when available and relevant to a particular case. For small, isolated populations (e.g., Native Americans) a  $\theta$  value of 0.03 will be used.
- 4.6.2.5 A "LR from Previous Report" will be generated.

This report will contain a number of different LR calculations for the POI and shall be included in the case file. The LR value reported will be the lowest Total LR from the three population groups incorporating the 99.0% 1-sided lower HPD.

Comparisons in which STRmix<sup>™</sup> assigns a POI to a contributor previously deemed uninterpretable, will be reported as an exclusion to the comparable portion of the profile. The report will be regenerated and the LR will be removed from the report.

If a single locus results in an LR of 0 while all other loci have LRs > 0 the forensic scientist needs to inspect the data closely.

The STRmix<sup>™</sup> internal validation data shows that the LR ranges below support the associated conclusion:

PP16 or PP16HS Data LR > 1,000 supports inclusion 0.001 < LR < 1,000 is inconclusive LR < 0.001 supports exclusion

## Fusion 6C Data

4.6.2.6 Repeat the "LR from Previous" process for each known reference sample where the comparison is probative. After analysis and review are complete, a copy of the STRmix<sup>™</sup> files for each case will be stored on the ISPFS network drive.

4.7 Major and Minor Contributors

4.7.1 LR statistical calculations performed by STRmix<sup>™</sup> take into account contributor order through incorporation of the factor of N! calculation. Therefore, the LR statistic applies to the mixture as a whole rather than a component (major or minor) of the mixture. Nevertheless, determination of major and minor contributors may provide useful qualitative information or be useful for CODIS searches. In addition to the criteria below, the mixture proportions and weights within STRmix<sup>™</sup> may be useful in determining major and minor contributors.

- 4.7.2 In a probable 2-person mixture (no more than 4 alleles at any given locus) it may be possible to determine a major versus minor contributor at some or all loci. A major profile is one in which a distinct, predominant DNA profile is present (as determined by number of peaks, relative peak heights, and peak balance). A minor contributor is the less predominant DNA profile in the mixture.
- 4.7.3 For loci where distinct major/minor genotypes are discernible (this will occur rarely in a mix of more than two individuals' DNA), both genotypes may be reported.
- 4.7.4 Given that heterozygous peak ratios are not 100% (complete balance), caution must be exercised in determining "shared alleles", as a scientist does not know (a priori) which allele of a heterozygous individual may be predominant (i.e., the "highest RFU peak" in the 3-peak mixture may not be the shared allele).
  Calculations to determine the relative peak height ratios of 3-peak loci may be performed to assist in this determination.

#### 4.8 Conclusions

4.8.1 PP16/PP16HS and Fusion: In general, an LR > 1 supports Hp (inclusion) and an LR < 1 supports Hd (exclusion). An LR = 1 is typically viewed as uninformative. STRmix<sup>™</sup> validation data shows that occasionally a known non-contributor can result in an LR > 1 and a true contributor an LR < 1. The range of LRs for which this may occur was observed to be between 0.001 and 1,000 for PP16 or PP16HS data and between 0.01 and 100 for Fusion data during internal validation. For this reason, STRmix<sup>™</sup> comparisons in which the LR is between 0.001 and 1,000 for PP16 or PP16HS data and between 0.01 and 100 for Fusion data will be reported as inconclusive. LRs > 1,000 for PP16 or PP16HS data and > 100 for Fusion data will be reported as an inclusion. LRs < 0.001 for PP16 or PP16HS data and < 0.01 for Fusion data will be reported as an exclusion. The numerical LR only needs to be reported for inclusions and inconclusive results.

Fusion 6C: The verbal scale above (4.6.2.5) will be used for Fusion 6C data. As LRs increase in magnitude, the scale reflects stronger degrees of support. LRs occur on a continuum. The categories recommended here have been chosen in part based on the observation that adventitious support for a proposition is most commonly observed within the Limited Support category and generally not expected within the Very Strong Support category. Adventitious support is described as an LR > 1 for an individual whose DNA is not present in the sample or an LR <1 for an individual whose DNA is present in the sample. While incidents of adventitious support in the limited support category represent the rare minority of observations, they reduce but do not eliminate confidence in the association of this person to the DNA sample.

The quality of the DNA profile and strength of the inclusion will be reflected in the magnitude of the LR. Note: See Section 10.3.7 of the Biology QA Manual for additional information on reporting of conclusions and statistics.

- 4.9 Paternity Statistics
- 4.9.1 For a paternity calculation, the LR corresponds to the PI (Paternity Index). The PE (Probability of Exclusion) represents the probability that a randomly selected individual would possess one or more alleles inconsistent with paternity.
- 4.9.2 In addition to the LR and PE used in paternity, the probability of paternity may be used. However, given that this statistic requires non-genetic information (i.e., the prior odds of paternity), the prior odds used (e.g., 50%) should be explicitly stated (See Biology QA Manual, section 10.3.6 for reporting of statistical frequencies).

# 5.0 Comments

- 5.1 Within PopStats the frequency for a heterozygous profile is determined by the equation f(pq) = 2pq and the frequency for a homozygous profile is determined by the equation f(pp) = p<sup>2</sup> +p(1-p)θ. However, STRmix<sup>™</sup> uses the Balding and Nichols model also known as NRC II recommendation 4.2.
- 5.2 Further information about STRmix<sup>™</sup> settings are detailed in the ISP Forensic Services STRmix<sup>™</sup> and Fusion 6C Validations.
- 5.3 More detailed information on the biological models, minimum allele frequency, and mathematical calculations underlying the STRmix<sup>™</sup> software can be found in the STRmix<sup>™</sup> Manuals.
- 5.4 Amelogenin, DYS391, DYS576, and DYS570 are not utilized in statistical calculations; however, these loci should be compared manually and the results should be consistent with the conclusions drawn.
- 5.5 Kinship statistics other than paternity may be calculated in PopStats when needed.

5.6 Legacy data may, on rare occasions, require reinterpretation for the purposes of STRmix<sup>™</sup> deconvolution and/or comparison to known reference samples. Any changes in interpretation will be documented in the case notes. (Note: to be qualified, an analyst and technical reviewer must first either receive training and competency testing, or reestablish technical skills/knowledge through the review of the previous .e .el Le. validation(s) and analytical method(s), and be approved by the Technical Lead for a

# Y-STR Analysis: PowerPlex® Y23 System (BI-214)

# 1.0 Background/References

- 1.1 Short tandem repeat (STR) loci found on the Y chromosome are referred to as Y-STRs. The ability to perform testing that is specific for male DNA is a valuable tool in forensic DNA testing, particularly in scenarios where an abundance of female DNA is present in a sample containing a significantly lesser amount of male DNA that is unable to be detected using traditional autosomal STR testing. The method for performing Y-STR testing is similar to that for autosomal STRs, with the main differences occurring at the interpretation and statistical calculation steps. The Y chromosome is inherited through the paternal lineage; therefore, male relatives are expected to have the same Y-STR haplotype. Due to the Y-STR loci being linked together on the Y chromosome a "counting method" is employed for statistical calculations. This paternal inheritance and Y-STR linkage imparts a much lower power of discrimination to Y-STR testing as compared to autosomal STR testing. #### 4.5 INTERPRETATION OF Y-STR RESULTS

- 4.5.1 Only single source and/or deduced single source Y-STR profiles will be interpreted. It may be possible to deduce a single source Y-STR profile, at all or some loci, in a mixture that is distinguishable into major and/or minor components. It may also be possible to deduce a single source Y-STR profile, at all or some loci, when the presence of a known contributor(s) (i.e. victim, consensual partner, etc.), whose DNA is reasonably expected to be present in a sample, can be assumed and the foreign alleles are attributable to a single individual.
- 4.5.2 Since the Y chromosome is haploid, a single allele is expected at each single copy Y-STR locus. Peaks detected with the PowerPlex Y23 kit must be above a 50 RFU analytical threshold in order to be considered allelic. The PowerPlex Y23 kit contains one multi-copy locus (DYS385 a/b) where two alleles are expected. The stochastic threshold for DYS385 a/b was determined to be 650 RFU for extracted samples and 225 RFU for direct amplification samples. Peak height ratios are generally >70% for samples with optimum amounts of input DNA. Duplications and deletions are rare genetic anomalies that may result in greater than or less than the expected number of alleles to be detected at a locus. A deletion causing a null allele may be differentiated from an undetected allele by considering the overall quality/peak heights of the profile and the location of the missing allele. It is permissible to use a null allele(s) in the Y-STR database search performed for statistical calculations. A sample is generally considered to be a mixture of more than one male if two or more alleles are present at two or more single-copy loci. An evaluation considering peak heights and repeat-unit differences at a given locus may be useful to differentiate between duplications and mixtures.

- 4.5.3 A mixture is considered distinguishable if it can be separated into major/minor components. In a 2-person male mixture it may be possible to deduce both the single source major and minor profile at all or some loci when the mixture ratio is greater than 2:1 (i.e. 67% & 33% contributors). For 3- and 4-person male mixtures it may be possible to deduce the profile of a major contributor at all or some loci when the major accounts for greater than 2/3 of the mixture (i.e. >67% contribution). Indistinguishable mixtures, minor contributors in 3- and 4-person male mixtures, mixtures of 5 or more males, and partial profiles with results at only a few loci will be considered uninterpretable. Caution should be exercised in distinguishing major/minor contributors when sub-optimal DNA input amounts were used resulting in a low level profile and/or at loci where peaks are of a similar height (i.e. near 50/50 in a 2-person mixture) even if the remainder of the profile is distinguishable.
- 4.5.4 Interpretation of questioned profiles, including deconvolution of mixtures, will occur prior to comparison with probative known reference profiles. Non-probative comparisons may be part of the interpretation process for questioned profiles to aid in determining number of contributors and whether or not a single source profile can be deduced from a mixture. A known and questioned profile comparison will be considered to be a match if all of the alleles detected in the questioned profile are consistent with alleles represented in the known profile. Reasonably explainable differences (i.e. allelic dropout, etc.) will not preclude declaration of a match. A non-match or exclusion occurs when unexplainable differences are present in the allele calls for the questioned and known profiles.

4.6 Y-STR STATISTICAL CALCULATIONS USING CADOJ Y-MIX TOOL

- 4.6.1 After a Y-STR profile is interpreted to be from a single male or deconvoluted into a deduced single male profile component of a mixture, and determined to match a probative known reference sample, a statistical calculation will be performed. A statistical calculation is not required for a non-match/exclusion or a match to a non-probative known reference sample if only a qualitative statement is to be reported. In cases where both autosomal and Y-STR testing has been performed, although it may be possible to calculate a combined statistic, the general practice will be to report autosomal and Y-STR statistics separately.
- 4.6.2 The "counting method" with application of a 95% upper confidence interval (UCI) using the Clopper and Pearson approach as recommended by SWGDAM (2014) will be used for Y-STR statistical calculations. The United States national database (with subpopulations) from the Y-Chromosome Haplotype Reference Database (YHRD <u>https://yhrd.org/</u>) will be the database used, and the CADOJ Y-Mix Tool will be the program used for performing the database search and calculations. The combined database consisting of African American, Asian, Caucasian, Hispanic, and Native American populations will be reported. Generally, the 95% UCI value reported will be in the format of "1 in X".

### 5.0 Comments

- 5.1 In general, Y-STR testing will only be performed on samples where male DNA was detected during quantitation. If the Auto:Y ratio is 250 or greater autosomal STR testing does not need to be attempted prior to Y-STR testing. Autosomal testing will generally be attempted prior to Y-STR testing when the Auto:Y ratio is less than 250.
- 5.2 There are a number of factors to consider prior to attempting Y-STR testing (i.e. availability of male reference samples for comparison, quantitation results, case scenario, results from other items in case, probative value, etc.); therefore, Y-STRs are considered complimentary to autosomal STR testing and may not be necessary in all cases.
- 5.3 These Y-STR interpretation, statistical calculation, and reporting guidelines represent the standard method used in most cases; however, they may not cover all scenarios encountered during forensic DNA casework. # Driftcon FTC: Temperature Verification (BI-400)

### 1.0 Background/References

- 1.1 Successful DNA amplification is dependent on consistent thermal cycling parameters and achieving proper heating and cooling to facilitate the various steps necessary for PCR. It is necessary to employ a method of monitoring the thermal cycler performance and verify that the correct temperature has been achieved in order to have confidence in the amplification process. A variety of temperature probes have been developed to test the temperature of specific wells within the different thermal cycler instruments. However, most of these have proven to be cumbersome, time consuming, and not amenable to testing the newer real-time PCR instruments. The Driftcon FFC is able to test multiple temperatures within a short period of time and can be used on the thermal cyclers, as well as real-time Forene instruments.

- 4.1.6 Choose the Driftcon default protocol and make sure the steps match those in the 9700 protocol. Leave the humidity, pressure, and temperature blank. Enter notes as needed (these will appear on the final report).
- 4.1.7 Start the test by clicking the check mark in the lower right corner. Make sure the 9700 has heated completely and the protocol started before starting the test. The protocol will complete in  $\sim$ 25 min.
- 4.1.8 Once the run has completed, print the report and place it in the QC binder or electronic equivalent.

  - 4.2.10 Start the 7500 run and Driftcon test. Start the test by clicking the check mark in the lower right corner. Make sure the 7500 has heated completely and the protocol started before starting the test. The protocol will complete in ~25 min.
  - 4.2.11 Once the run has completed, print the report and place it in the QC binder or electronic equivalent.

- 5.1 The second page of the report contains information regarding the number of measurements for each probe. The number should be approximately double the protocol time. If significantly higher or lower, the instrument may be heating too slowly or too quickly. The percentage should be 100% for each probe. If a percentage is lower than 100%, the probe may not have been in the well and measurements missed. Adjust the probes and run the protocol again.
