The Idaho State Police's Pass-Through Grants and Research Department (ISP PGR) is the State Administering Agency (SAA) for the Edward Byrne Memorial Justice Assistance Grant (JAG), a federal passthrough formula grant awarded annually to states by the Bureau of Justice Assistance (BJA), U.S. Department of Justice. As Idaho's SAA for JAG funding, ISP PGR is required to collect and report data pursuant to the Deaths in Custody Reporting Act (DCRA) of 2013 (Public Law 113-242) to BJA. ISP PGR collects DCRA reports from state and local law enforcement and correctional agencies on a quarterly basis and compiles those reports for submission to BJA.

The Idaho Statistical Analysis Center (ISAC) coordinates data collection and provides technical assistance to Idaho agencies that are required to report. This document highlights some frequently asked questions (FAQs) about DCRA reporting.

What is a reportable death?

A death of "any person who is detained, under arrest, or is in the process of being arrested, is en route to be incarcerated, or is incarcerated at a municipal or county jail, State prison, State-run boot camp prison, boot camp prison that is contracted out by the State, any State or local contract facility, or other local or State correctional facility (including any juvenile facility)."

"Detained" means police contact that results in an individual being delayed from going about their intended business, a standoff, hostage situation, or police pursuit. For example, a traffic stop, questioning an individual who matches a suspect description, or a check-on-the-welfare for a person who appears to be in distress.

Common examples of reportable deaths include officer-involved shootings; deaths related to the use of force or law enforcement compliance weapons (tasers, stun guns, nightsticks); or fatal accidental injuries sustained while attempting to elude officers, such as falls from heights and drowning; and suicides committed during standoff and barricade scenarios.

Other examples of reportable deaths are those not directly related to either police action or negligence, such as deaths attributed to intoxication, suicide, accidental injury, and illness or natural causes that occurred during law enforcement interaction or while in custody. Deaths attributable to drug overdoses or COVID-19 should be classified as "Other", with the cause of death written into the description box.

As a guiding principle, please do not exclude a case on the basis that physical custody had not been established. This point is highlighted through cases involving officer-involved shootings. Virtually none of these cases involve subjects who were already in the physical custody of law enforcement personnel.

How to report a death using ISP Web Forms

Starting in July 2025, DCRA reporting will be completed online via the ISP Web Forms application. In order to submit DCRA reports, users must first register for an ISP Web Forms account. At the beginning of each reporting period, all registered users will receive a DCRA reporting reminder email from ISP Web Forms which will include the due date, links to submit reports online, and links to other relevant information such as these FAQs.

The reminder emails will include two reporting links:

- "Zero" Reports: One link will allow you to confirm that your agency had no reportable deaths
 This link will allow you to submit a "zero" report for your agency without logging into ISP Web Forms
- **One or more reportable deaths:** The other link will take you to ISP Web Forms, where you will log in and submit any reportable deaths for the quarter.

Viewing/Updating Previously Submitted DCRA Reports

To view or update an older DCRA report (for example, after an investigation has concluded), log into ISP Web Forms (<u>https://apps.isp.idaho.gov/ISPWebForms/</u>) and click on "Submitted DCRAs" at the top of the screen. This will show you a list of previously submitted reports for your agency. To update a form, open that incident by clicking on it and edit the information as needed. When you are finished updating the incident, click the "Submit" button at the bottom of the screen.

What information should be included in the narrative/description sections?

The Bureau of Justice Assistance (BJA) is looking for a few specific pieces of information in the description section:

- Date, time and location of the incident
- Responding agency or agencies
- Characteristics of the incident
 - Why was the deceased in custody or being pursued?
 - What specific circumstances led to the individual's death; OR
 - When and how did law enforcement or correctional officer(s) discover the deceased?
 - How did officer(s) respond during the incident?
 - Was a weapon present during the incident?

To ensure each report captures these elements, the narrative section of the reporting form has been split into five separate questions:

- Why was the deceased in custody or being pursued?
- What specific circumstances led to the individual's death; **OR** When and how did law enforcement or correctional officer(s) discover the deceased?
- What specific actions did the officer(s) or facility staff take during the incident?
- Was a weapon present during the incident?
- Additional Details

All fields are required (except for Additional Details). ISP Web Forms will not allow these fields to be left blank unless the manner of death is listed as "unknown, investigation pending".

For incidents still under investigation, these fields can be left blank if the information is not known at the time the report is submitted. After the investigation is concluded and the manner of death has been updated, these fields cannot be left blank.

Example of a Good Narrative

For reference, an example incident narrative provided by BJA is shown below. The key pieces of information noted above are highlighted in yellow, followed by a description of where each piece of key information should be filled in on the online DCRA reporting form in ISP Web Forms.

Decedent Information: BJA Manner of Death and Brief Circumstances

Manner of Death: Natural Causes

Brief Description Examples:

Several medical conditions.	Inmate housed at prison hospital for end-of-life care due to metastatic bladder cancer.	On 02/08/2021 at 18:45, nursing staff went to check on decedent during walking rounds. He was unresponsive with rapid respiration, decreased oxygen, decreased oxygen saturation, and weak pulse. Supplemental oxygen was applied at 15 liters per minute via non-rebreather mask. The on-call physician was phoned, orders were given, he was transferred from the institution's infirmary cell to stretcher, and he left the facility in an ambulance with custody escort at 19:30. On 02/09/2021, the medical center called the institution and informed them that the decedent suffered a cardiac arrest while in ICU and was pronounced deceased at 10:53.

Based on this incident, the five questions on the reporting form should be filled in as follows:

- Why was the deceased in custody or being pursued? Decedent was being housed in the prison hospital for end-of-life care.
- What specific circumstances led to the individual's death; OR When and how did law enforcement or correctional officer(s) discover the deceased?
 On 2/8/21 at 18:45, nursing staff went to check on decedent during walking rounds. He was unresponsive with rapid respiration, decreased oxygen saturation, and weak pulse.
- What specific actions did the officer(s) take during the incident? Supplemental oxygen was applied at 15 liters per minute via non-rebreather mask. The on-call physician was phoned, orders were given, he was transferred from the institution's infirmary cell to stretcher, and he left the facility in an ambulance with custody escort at 19:30.

- Was a weapon present during the incident? No.
- Additional Details

On 2/9/21, the medical center called the institution and informed them that the decedent suffered a cardiac arrest while in ICU and was pronounced deceased at 10:53.

What if there is an ongoing investigation into a reportable incident when quarterly data collection begins?

Deaths that are under investigation when data collection begins should be indicated by selecting "Unavailable, investigation pending" option under "Manner of Death". Updates must be provided to PGR at the conclusion of a DCRA death investigation if this option is selected. To update an incident, log into ISP Web Forms and select the incident that needs to be updated (see page 2 of these FAQs for additional instructions).

If more than one agency was present at the time of the death, which agency is responsible for reporting the death?

The agency that is considered to have jurisdiction over the decedent at the time of death is responsible for reporting the death. When multiple agencies are considered to have jurisdiction then follow the guidelines below.

- Multi-agency: The agency of the officer whose actions resulted in the death must report the incident.
- Multi-agency (unable to determine which officer's actions resulted in the death): The primary jurisdictional agency must report the incident. Examples:
 - o Local Police Department Sheriff's Office: Local Police Department reports
 - o Local Police Department State Agency: Local Police Department reports
 - o Sheriff's Office State Agency: Sheriff's Office reports
- Other scenarios:
 - Off Duty Officer: The agency with whom the officer is employed must report the incident.
 - Federal Agency: On or off-duty officer, the primary jurisdictional agency must report the incident.
 - Task Force Member: The agency with whom the officer is employed must report the incident.

Examples of Reportable and Non-Reportable Scenarios

Decedent commits suicide while law enforcement officers are present on the scene

 Response is for a person with a mental disturbance or a distraught person, where result of police custody would have been to transport the subject for mental health evaluation prior to determining any criminal charges.

Yes, this is reportable.

- Response is for a person who is a suspect of a crime, or a person wanted for questioning of a crime, whether an arrest warrant has been issued or not.
 Yes, this is reportable.
- Response is for a person who has fled from police custody, and who has committed no other crime.

Yes, this is reportable, if law enforcement is in "active pursuit" where the offender is fleeing law enforcement. However, if the offender has fled and "active pursuit" has ended, but it becomes an active investigation/search and the suspect is later found dead, then the event is not reportable.

Death occurred during a police pursuit

- Police officers pursue a suspect, during which the suspect produces a weapon creating a threat to
 officer safety. Suspect is then shot and killed by officers without an officer ever having "put hands
 on the suspect" to physically attempt an arrest prior to the shooting.
 Yes, this is reportable.
- Suspect crashes and sustains fatal injuries while officers are engaged in an active vehicle pursuit. **Yes, this is reportable.**
- Suspect crashes and sustains fatal injuries after officers terminated a pursuit for safety reasons and no police vehicles are obviously in pursuit.
 No, this is not reportable.
- What about people who are killed indirectly due to a law enforcement pursuit?
 No, this is not reportable. Indirect deaths (such as bystanders) are not included in the statute.

Other Scenarios

 Police contact results in an individual being delayed from going about their intended business (i.e., a brief detention—a traffic stop, questioning an individual who matches a suspect description, a welfare check for a person who appears to be in distress). The individual contacted then has a medical emergency and dies.
 Yes, this is reportable.

- An inmate is transferred to a medical facility and dies there, not in a correctional facility. Yes, this is reportable if an inmate is considered to be detained and under the supervision of law enforcement, detention, or correctional staff. If an inmate dies while on furlough and the furlough has a set end date, this is reportable. However, if the furlough did not have a set end date, this is not reportable.
- Law enforcement assists during transport to a hospital or mental health facility and the person dies.

The death of a noncriminal person that occurs in the custody of law enforcement personnel in these circumstances **should not be reported**, unless circumstances change and the person commits a criminal action.

Example: A person is being transported to the hospital for a psychiatric evaluation. During transport the person begins kicking out the windows of the squad car. If the incident escalates and the officer's actions result in the death of the individual, the incident must be reported.

• A person dies after being restrained for their own safety, or for the safety of medical personnel on the scene.

Yes, this is reportable. Please note that if such persons die at medical/mental health facilities following police transport, they are not reportable unless the final determination of cause of death is directly linked to the period of detainment or custody by law enforcement, detention, or correctional staff.

- Law enforcement personnel are attempting to arrest a fleeing suspect when the suspect collides with a civilian operated vehicle and sustains fatal injuries as a result.
 Yes, this is reportable. The death should be recorded as "Accidental."
- Law enforcement personnel are dispatched to a robbery in progress at a convenience store. Upon arrival at the scene, law enforcement personnel discover a struggle between the suspect and store clerk. The store clerk fatally wounds the suspect in the presence of law enforcement personnel.

Yes, this is reportable. In this instance, the manner of death should be recorded as "Homicide."

Decedent Demographics

What if the decedent's race does not fit any of the available options?

The Bureau of Justice Assistance (BJA) will only accept the race categories on the form as valid options (e.g., "Other" is not a valid response to this question). If the decedent's race does not match one of the available options, there are a few ways of reporting the decedent's race accurately:

- Follow the reporting rules used by the Uniform Crime Reporting (UCR) Program. For example, under UCR's reporting guidance, individuals of middle eastern descent should be categorized as "Asian".
- If the decedent is of two or more races, check all categories that apply.

• If the decedent's race is truly unknown or the previous two reporting options still are still not accurate, check "Unknown" and add a note explaining the decedent's race in the Additional Comments box at the bottom of the form.
