I. Opening

- 1) Call to Order
 - a) Chairman Sheriff Mike Hollinshead called the meeting to order at 02:11 p.m.
- 2) Silent Roll Call of Board Members
 - a) A roll call was conducted. All Board members were present in person. Quorum achieved.
- 3) Welcome new Board Member Chief Allen Fullmer from Rigby PD
- 4) Approve Minutes from the October 28, 2024 and January 23, 2025 meetings
 - a) Vote to approve minutes from October 28, 2024 and January 23, 2025 meetings
 - Chairman Hollinshead called for a motion, Sheriff Gough moved to approve both October 28, 2024 and January 23, 2025 minutes. Colonel Gardiner seconded the motion

Votes in favor: 5

Votes to abstain: 1 Chief Fullmer abstained due to not being present for both meetings.

Votes against: 0 Motion passed

II. Informational

1) 67-3008 language update

a) A copy of the Criminal History Statute was provided in the folder. We have submitted fingerprints to the FBI under the National Child Protection Act for years. The FBI Auditor suggested, during our last FBI Audit, that we add language to include authority for our private noncriminal entities to the statute. We added, "and any persons associated with private, noncriminal justice entities that qualify under the National Child Protection Act of 1993 and volunteers for Children Act that serve vulnerable populations such as children, the elderly, and individuals with disabilities", to the statute

Lt. Col. Wheatley took this to the Legislature Judiciary and Rules committees which was accepted and it is now part of statute.

2) Disposition recovery project

a) We are working with a vendor to create an electronic interface. This would look at incoming dispositions that come from the courts which do not have an automatic match to an arrest in the criminal history database. Currently, records with incomplete or inaccurate information are being placed in a hold file to be reconciled at a later date. Due to a lack of staffing resources, this file has not been worked on a regular basis. The vendor will design a process that will use machine learning to help connect those files coming from the court to arrest records in the BCI database.

We were awarded a federal grant in 2023 for this and Dawn Peck is currently working with the vendor to automate this process. This would allow the computer to do this quicker than we could do on our own.

The project is moving forward however the grant award will end in December so we may need to get an extension, which would push the project timeline out an additional year.

III. Old Business

1) ILETS budget/fee structure review – BSU finance Brian Knox and Allen Hartt

a) Brian Knox and Allen Hartt presented their findings and suggestions. They suggested a Per-capita structure rather than the current usage structure. They developed several different alternatives to usage fees which are outlined in Appendix A attached.

Some board members prefer that the state pay for system costs and provide access free to the local users, or even a portion of the costs. It is not likely that the legislature will agree to approve that option. The board is leaning towards a hybrid of options using per capita and a forced ranking-type methodology.

b) Vote on fee structure proposal

 Chairman Hollinshead called for a motion to table the vote to study the presented information. Chief Johnson moved to table the vote, and Major Smith seconded.

Votes in favor: 6 Votes against: 0

c) Budget analysis review

 Leila went over the FY25 budget information. If there are any questions or you need more information, please email her and she will get an answer for you.

2) ILETS circuits update (BLM, ITD, Buhl PD)

- a) BLM requested connection, the microwave is connected, we are working on the Syringa connection, once the line is established, we will start them off at the lowest usage level under the current fee schedule.
- b) ITD, the microwave is set up, and the primary connections have been made.
- c) Buhl PD, we are waiting for them to move to their new building. ETA unknown.

3) Disaster Recovery Budget update

a) ISP's budget was approved, and we were granted our ongoing cloud-based recovery costs. We need to obtain quotes from both AWS and Nlets and choose the one with the lowest implementation cost.

4) State IT modernization of ISP and its effect on ILETS

a) June 9th is the date set for ISP to be modernized into ITS. We are still working on access requirements with ITS. ITS is still working on discovery, management agreements levels and service agreements.

The NOC, now known as ICC, is now under BCI. We are currently down five staff members, but we are working on getting that number back up to full staff.

IV. New Business

1) ILETS Board By-laws discussion

Legal wanted to know if we have any By-laws or internal operating rules. Teri would be willing to draft something for the board to review. The ILETS statute does include some information, but we may want to clarify through a board document. There may be something in executive orders, Colonel will look into it for Teri.

a) Vote on By-laws creation

 Chairman Hollinshead called for a motion to have By-laws drafted for the board to review at the next meeting. Chief Johnson motioned to have By-laws drafted for the board to review at the next meeting, and Chief Fullmer seconded.

2) ILETS manual addition of security policy language

- a) The FBI has updated its CJIS security requirements over the past few years. Our ISO has requested that we revise our security policy. These revisions have been included in the board members' packets for review, and if they would like to add anything or have anything explained, please contact Leila.
- b) The storage of audio or video evidence recordings was discussed, which may require clarification.

3) Elect Chairperson

a) Vote on Chairperson

 Chairman Hollinshead called for nominations for the Board Chair position.
 Sheriff Gough nominated Sheriff Hollinshead for Chair and was accepted by unanimous acclimation.

4) ILETS budget/fee structure review – BSU finance Brian Knox and Allen Hartt

a) Brian Knox and Allen Hartt presented their finding and suggestions. They set up a survey and received replies from 20 different states across the US. They found that 50% of the responding states have a governmental body paying 100% of the fees; the remaining 50% of the responding states have the state governmental body paying at least 50% and up. There are only two states that structure their fee schedule similarly to ours.

Through the survey, they presented two scenarios: an officer deciding whether to use ILETS. In the first scenario, the officer is in a budget-strapped department with no usage fee. In the second scenario, the same officer, in the same department, faces a usage fee and is warned against excessive ILETS usage due to budgetary reasons. The survey showed that there was far less likelihood that the officer would use ILETS on a standard stop due to budget constraints.

They do not recommend the current fee structure or any structure that revolves around usage. They believe a per-capita structure would be better suited because use of the system does not affect costs. They developed five different alternatives to usage fees, but do not recommend option 5.

- Option 1 funding through state legislature/agency
 - About 50% of the states that responded to the survey have this option.
- Option 2 Per capita (head count) fees replacing usage fees
 - o A fee based on the population of the city or county
 - o State/Federal/Tribal agencies would be at 0%
 - Largest increase without fee adjustment would be 66,439.00, with fee adjustment \$79,795.77 to one agency
 - Largest decrease without fee adjustment would be 65,875.00, with fee adjustment \$65,368.75 to one agency
 - o Some counties' obligations go down, and city PD's increase
 - Have to decide on the state agency costs for the set cost

- Option 3 Per capita fees incorporating a measure of income (Brian and Allen' recommendation)
 - o Adjusts population percentages by median household income in a given population
 - Largest increase without fee adjustment would be \$29,314.00, with fee adjustment \$40,691.99 to one agency
 - Largest decrease without fee adjustment would be \$37,125.00, with fee adjustment \$33,387.50 to one agency
 - Some counties obligations go down and some city PD's increase
 - This levels out to areas that can afford the costs and areas that may not be able to afford the costs

- Option 4 Per capita fees using forced ranking
 - O Levels could be fixed in number, e.g., the top 3 users are in the top level, the next 5 users are in the next level, etc. This ensures that there will always be a certain number of users in each level whether based on usage or population.
 - O You would use a graduated number of users per level
 - o 3- level 10
 - o 5- level 9
 - o 7- level 8
 - o 9- level 7-2
 - o Level 1 would be the remaining agencies
 - o The largest increase with fee adjustment would be \$228,380.00 to one agency
 - The largest decrease with fee adjustment would be \$68,078.00 to one agency

- Option 5 Additional High usage level
 - o Just added an additional level and reduced level 8 from 5% to 4%
 - o This moved 4 agencies up a level
 - This level does increase the fund but does nothing to encourage smaller agencies to use ILETS

The board is leaning towards a hybrid of options 2 and 4, with 10% of the total costs allocated to the State, Federal, and Tribal entities, and then split up between those entities accordingly. We would start the pricing for the remaining amount with the top population area, and divide that population by the remaining dollar amount, and then work our way down from there. We would need to implement this over several years to reach \$2.4 million due to the city and county expenditure caps.

Colonel Gardiner would like to see a schedule that lists fees structured on a per capita basis as a percentage of the total costs estimated to be needed for only the local entities. We would have to figure out each county's percentage of the state in population. Then, we would take those numbers and divide them by whatever estimated total needed
