AGENCY OVERVIEW

Founded in 1919 as the Bureau of Constabulary, the Idaho State Police continues to serve as Idaho's statewide law enforcement agency, providing public safety services through fair and professional policing. More than 700 sworn and professional employees work together to support communities across the state through enforcement, investigation, forensic science, communications, and specialized technical expertise.

ISP troopers, strategically positioned across Idaho's highways and communities, are responsible for enforcing state laws, investigating crime, and responding to emergencies. Their work, which includes patrolling, conducting traffic stops, and investigating crashes, is focused on protecting lives, maintaining public order, and ensuring the safety of Idaho's residents and visitors.

Behind the scenes, our professional staff play a crucial role in strengthening every part of our operation. From forensic scientists who process evidence in modern crime labs to dispatchers who manage emergency communications, these skilled professionals ensure that critical services are delivered efficiently and accurately, instilling confidence in our capabilities.

ISP is committed to adapting to Idaho's changing needs. The agency continues to invest in technology, training, and strategies to address serious threats such as fentanyl trafficking, human trafficking, and violent crime. Through initiatives like Esto Perpetua, ISP works to reduce the impact of dangerous drugs and keep communities safe.

As Idaho grows, so does the responsibility to safeguard it. ISP remains focused on its mission: to provide safety and security through professional service, strong partnerships, and public trust.





Be a model law enforcement agency and an innovative leader in public safety services across Idaho.


We are an agency that:

REVENUE & EXPENDITURES

Idaho State Police receives revenue from the General Fund, dedicated funds and federal funds. Generally, revenue collection for dedicated funds is built into user fees or taxes that finance a specific service or project—for example, fingerprint fees.

General funds are collected from taxes and fees imposed by the state, such as individual income and corporate tax, whereas federal funds include allocations for specific programs for a specific purpose. Federal funds are often passed through other state and local governments for criminal justice activities.
