

Introduction

Idaho Code Chapter 29, Title 67, Section 67-2919 requires Idaho State Police Forensic Services (ISPFS) provide a legislative report regarding sexual assault evidence collection kits in Idaho on or before January 20th of each year regarding the examination of sexual assault evidence collection kits throughout the state in the previous year. The report shall include, but not be limited to, the number of kits purchased and distributed by Idaho State Police Forensic Services, the number of kits collected by each law enforcement agency, the number of kits tested by the Idaho State Police Forensic Services laboratory, the number of kits not submitted to the Idaho State Police Forensic Services laboratory pursuant to subsection (8) of the statute, the number of DNA database hits from sexual assault evidence kits, the number of unresolved DNA database hits from sexual assault evidence kits for each law enforcement agency, the number of sexual assault evidence kits submitted without required reference samples for each law enforcement agency, and a list of any law enforcement agencies that did not adhere to the tracking process promulgated pursuant to subsection (9) of the statute. This report also contains updates made to the Idaho Sexual Assault Kit Tracking System (IKTS), statistics from the ISPFS crime lab, information about the Idaho SANE/SART training program, and issues related to sexual assault evidence collection kit tracking and processing during the 2025 calendar year.

Idaho Sexual Assault Kit Tracking System (IKTS)

In January of 2017, Idaho became the first state to fully implement a statewide sexual assault evidence collection kit tracking system. This tracking system provides greater public accountability and transparency, provides more resources to the state forensic laboratory, and ultimately provides more transparency to victims of sexual assault. Sexual assault survivors and the public can track the sexual assault evidence collection kit without having to have a login. Survivors are provided with a tracking number for their kit at the time of collection. Use of this


system has resulted in several survivors asking additional questions of law enforcement, the forensic lab, and Idaho legislators.

Training and Sharing IKTS

The ISPFS IKTS Administrator provided training and met with several medical and law enforcement organizations throughout the past year. The IKTS software is provided free of charge to any publicly funded entity that would like to adopt the program. ISPFS provides the digital download of the software program. Some organizations modify it slightly for their specific needs, while others use it to develop their own custom kit tracking system. In 2025, several states made inquiry about the system. See **Appendix A** for a list of organizations and their status with the Idaho software.


Sexual Assault Evidence Collection Kits Purchased & Distributed

Idaho State Police Forensic Services procures the sexual assault evidence collection kits with a legislative appropriation within state purchasing rules and agreements. The new kits are entered into the IKTS system by ISPFS using a unique serial number on the box. The kits are then distributed to hospitals, clinics, and other collection entities in Idaho. A comparison of past years' inventory is displayed below:



Sexual Assault Medical Forensic Examinations

Hospitals and clinics in Idaho, and surrounding states, perform sexual assault medical forensic examinations. When custody of a kit collected in another state is turned over to an Idaho law enforcement agency, it is assigned an Idaho serial number and tracked from that point forward in the IKTS system. 501 kits were collected in Idaho in 2025, and 46 of those were anonymous.



Law Enforcement (LE) Information

All sexual assault evidence kits collected in Idaho, where the allegation has not been determined to be unfounded, shall be processed by the Idaho State Police Forensic Services laboratory. Exclusions include kits of victims/survivors who wish to remain anonymous under the provisions of the federal Violence Against Women Act (VAWA).

Law Enforcement agencies are required to obtain the sexual assault evidence collection kit from the collection facility, and either submit the kit to ISPFS for analysis or document the decision not to test in the IKTS system. A list of participating LE agencies is outlined in **Appendix B**.


Any sexual assault evidence collection kit, excluding anonymous kits, that are not submitted to the lab for testing must be independently reviewed by the county prosecutor. **Appendix C** outlines the sexual assault kit decisions by agency. Kits that were collected anonymously but were not tested under the federal Violence Against Women Act (VAWA), are presented in **Appendix D**.

Often sexual assault evidence collection kits need reference samples from either suspects or consensual partners. It is a constant challenge for law enforcement to collect these samples after

the initial crime report. **Appendix E** outlines the number of sexual assault evidence collection kits completed by ISPFS during 2025 that lacked required reference sample submission.


ISPFS Laboratory Analysis

Throughout 2025, ISPFS continued to struggle to fill open DNA positions due to lack of qualified candidates and low pay. New hires are typically new in the field and require two (2) years to fully complete training. Throughout 2025, ISPFS had two fully trained federal grant funded contractors working remotely contributing to the success of the DNA program. At the end of 2025, one of the contractors resigned, leaving the second federally funded contractor position open. At this time, we also have four grant funded limited-service positions. Three of these positions have been filled and the analysts are working to complete training. One position remains vacant and ISPFS will continue to attempt to fill this vacancy in 2026.



All profiles developed from evidence items in submitted sexual assault evidence collection kits that are eligible for Combined DNA Index System (CODIS) entry, per Idaho state statute and National DNA Index System (NDIS) policies, are entered into CODIS. These profiles are compared to profiles from other evidence samples, convicted offender profiles and arrestee profiles (entered by states that allow arrestee sample collection) nationwide. In the event a profile developed from an item in a sexual assault evidence collection kit hits against another evidence sample a report is issued to the agency and they are notified of the other agency's contact information. Convicted offender samples and arrestee samples do not have a chain of custody and are not considered evidentiary. In the event a profile developed from a kit item hits against a convicted offender or an arrestee, a report is issued to the agency notifying them of the

hit and the individual's name along with a request to collect a new sample to verify the hit. A phone call or email is also placed/sent to the agency with any additional information available on the individual offender or arrestee. Follow-up on one of these hits would be a phone call or email stating why a second sample will not be collected (prosecution declined, case adjudicated, etc.) or submission of the second sample. **Appendix F** reflects the number of DNA database hits from sexual assault evidence collection kits and the number of those hits that are unresolved by law enforcement agency.



Idaho Code Chapter 29, Title 67, Section 67-2919, states that kits have 90 days from the time they are received by the lab to be analyzed; going over this 90-day limit does not affect the ability to prosecute or defeat the jurisdiction of the court, but it does result in prolonging that process. ISPFS does not currently have the resources to analyze all kits that are received each month in the 90-day timeframe. ISPFS provides a report to the legislature every month of any kit above the 90-day timeline. The graph below shows the number of kits that were at the lab in excess of the 90-day limit. ISPFS prioritizes the kits that are received. If an agency indicates in the submission the kit is low priority (prosecution declined, victim no longer wishes to proceed, etc.) the kit is not worked as quickly as those that are submitted as part of an active investigation needing a quicker turnaround time.

The Idaho State Sexual Assault Response Team (ISSART)

The Idaho State Sexual Assault Response Team (ISSART) working group was founded by ISPFS in 2014, as the Idaho Sexual Assault Kit Initiative Team (ISAKI). This volunteer multidisciplinary policy advisory group consists of state and local law enforcement, specialty organizations representing varying agencies, the forensic laboratory personnel, prosecutors, a public defender, a judge, a court representative, several victim advocacy and resource groups, victim compensation fund administrators, sexual assault nurse examiners (SANEs), a physician, hospital administrators, grant experts, and a state Senator.

This group meets every quarter to discuss issues that have occurred throughout the state of Idaho. Issues are assessed regarding the level of service and care to victims, increase sexual assault training for law enforcement, mandatory reporting guidelines, and how to properly address anonymous sexual assault evidence collection kits.

For this past calendar year, the ISSART working group completed or updated the following items:

- Prior to the sexual assault legislation going into effect, sexual assault evidence collection kits that were sent to the ISPFS lab may have been returned without completed analysis per the direction of the submitting agency. Additionally, the laboratory may have only performed biology screening and not completed DNA analysis on a kit for a variety of reasons. All of these are considered partially tested

kits. The newly formed Sexual Assault Kit Initiative (SAKI) cold case team, with the assistance of the ISPFS DNA unit, worked to compile a list of all partially tested sexual assault evidence collection kits statewide. The team then began the process of helping agencies resubmit all still existing partially tested kits for full analysis at ISPFS in 2024, and the project continued into 2025. During 2025, 44% of the partially tested kits were completed.

- SART/SANEs continued to work on creating a Strangulation manual. This will be a standalone manual on strangulation, and our SANE/SART Coordinators are working directly with experts from the Institute of Strangulation to develop this manual. When completed, this manual will provide much needed information on how to identify strangulation victims, and information on how to best help them.
- Several research projects in conjunction with the Projects, Grants, and Research department at the Idaho State Police, and Boise State University were undertaken. Many of these projects were shared at ISSART meetings throughout the year. Presentation topics included: Intimate Partner Violence, Sexual Violence in Idaho, Sexual Assault Processing, and updates to the Idaho Crime Victim Services Dashboard.
- Conducted pivotal conversations with advocates, and POST (Peace Officer Standards and Training) about valuable training topics for Idaho law enforcement officers.
- Collaborated with the Nampa Family Justice Center on the Neurobiology of Trauma training.

Challenges to Kit Tracking

Throughout the year, there have been some challenges related to the IKTS program, with some previous challenges being overcome. Some of the challenges to the IKTS tracking program are outlined below:

- There has been high turnover for medical and law enforcement personnel throughout the state. The challenge of ensuring IKTS users are correct and trained for organization(s) is constant.
- Some organizations are not completing the information for collected sexual assault evidence collection kits or updating their status in IKTS. This is a daily endeavor reaching out to organizations for the required information.

The IKTS Administrator and other ISPFS staff offer training in person or online for any organization that would like to have additional information. Unfortunately, most organizations have not accepted the invitation to this training.

IKTS Software Development and Use Statistics

IKTS is continually enhanced by Idaho State Police web programmers. Having IT programmers at ISP allows the IKTS administrator to make real time changes to the system as the process has been refined. See **Appendix G** for the annual IKTS use statistics for 2025.

Idaho SANE/SART Coordinator Positions

The Idaho State Police Forensic Services (ISPFS) filled the second SANE/SART Coordinator (SSC) position in April 2025. Cari Whitson, RN, filled this position. Deb Wetherelt, RN, the SSC for the last five years, retired in November 2025. ISPFS is actively working to fill the second SSC position. The Idaho SSC continues to oversee and administer a training program to increase the number of SANE trained nurses, develop a sustainable training program for entry-level and continuing SANE training, to maintain the statewide sexual assault kit response guidelines, to coordinate the efforts of the ISSART group's ongoing initiatives, ensure implementation and continual review of state sexual assault evidence collection policy and procedures, and to help coordinate resources and other operational issues in all Idaho sexual assault evidence collection facilities. The Idaho SSC also works directly with ISPFS DNA scientists to make updates to the Idaho Sexual Assault Evidence Collection kits to facilitate improved collections.

Competence and Practice:

Throughout 2025, the first SSC (Deb) completed 46.5 hours of continuing nursing education specific to SANE nursing. She also completed education that does not provide nursing education hours, on topics including: How to Conduct the Forensic Medical Exam for the Strangled Victim of DV (Domestic Violence), Crucial Conversations, Update from the Institute on Strangulation Prevention, What Survivors Want you to Know, Recantation, Domestic Violence, Trauma Aftercare, Post Traumatic Stress in DV, Culturally Responsive Care, Detecting Bruises Using Alternate Light and DNA Essentials for Forensic Nurses. Additionally, she completed 624 hours of call in Hailey, Idaho at Blaine SAFE for personal SANE work to ensure she remains competent in the provision of care for the patients who have suffered sexual or intimate partner violence.

Our second SSC (Cari) was oriented and started training in April of 2025. She completed 180.5 hours of continuing nursing education specific to SANE nursing, this included the 40 hour SANE-A class, 16-hour skills lab and a 30-hour Person-Centered Adult Sexual Assault Simulation lab. She also onboarded with the Domestic Violence and Sexual Assault Center in Idaho Falls. This required a 90-day orientation which included 86.5 hours continuing nursing education and three observed exams by a mentor. This allowed her to complete 423 hours of call to increase her knowledge and skills as a SANE nurse.

Improving Access to Standardized Care after Sexual Assault:

Ten 40-Hour SANE courses were originally scheduled for 2025, two were canceled due to insufficient nurse enrollment. The remaining eight classes trained 21 nurses, bringing total of SANE trained nurses in Idaho to 283. In response to requests from previously trained SANE's, a specialized 8-hour refresher course was developed to maintain clinical competency. Eight nurses were trained in two separate classes. The first Coordinator also taught two Forensic Nursing: Collaboration with Law Enforcement trainings. In total, 14 law enforcement personnel, 5 EMS and 2 nurses attended this training. Mock Exams were provided at two sites training 14 nurses. St. Lukes launched a TeleSANE service at 4 sites (Wood River, Elmore, McCall & Jerome). This service is provided through Pennsylvania State University. To assure standardized statewide forensic procedures the SANE SART coordinators collaborated with Penn State to record an evidence collection training session based on the Idaho State Police Forensic Services protocol. This resource will serve as the standardized training foundation for all TeleSANE nurses operating in Idaho. In 2020, Idaho identified only three sites with SANE-trained RNs to perform medical forensic examinations. **As of 2026, that number has expanded significantly to 38 locations across the state.**

Nurses who have completed the 40-hour SANE-A class taught by ISPFS have historically been encouraged to sit for the SANE-A international certification. While certification demonstrates the highest level of training, proficiency, and experience with patient care, certification is not a requirement in Idaho to provide forensic medical care or forensic services. We have relied on the International Association of Forensic Nursing (IAFN) to accredit our training classes and certify our nurses. Toward the end of 2025, IAFN notified all members that they would be undergoing a radical restructuring that involved reduction of staff and suspension of many of their services. They reported these reductions were the result of fraud committed by a former employee that is now under federal investigation. Please note, ISPFS is not involved in IAFN management, operation, or leadership decisions. The impact of suspended services includes the opportunity for nurses to sit for new certifications, as well as to apply for recertification and the approvership program. All ISPFS classes remain accredited and will continue to be offered to Idaho medical providers. The Forensic Nursing Certification Board (FNCB) is in the process of finalizing pathways for supporting currently certified SANEs and those who have completed the required training to be certified. ISPFS remains committed and dedicated to high quality forensic nurse education, training, and mentorship. We continuously and constantly evaluate the forensic nursing education and training being provided to ensure it meets the highest national and international standards. Actions taken by IAFN will not deter Idaho from pursuing forensic nursing excellence for the compassionate care for survivors of sexual assault and domestic violence.

In 2025, the first SSC offered several trainings and presentation held throughout Idaho, including: Trauma Informed Care, Hurting without Helping: Consensual Strangulation, The Medical Forensic Exam: Forensic Nursing, Collaboration with Law Enforcement: Dating Apps and Sexual Assault. She also presented at the Academy of Forensic Nursing Regional Conference in Tacoma, WA, Embedding Forensic Nurses in a State Crime Lab and the 6th Asia-Pacific Advanced Nursing Practice, Nursing Education, and Leadership Conclave in Singapore.

The SSCs continue to work with the Forensic Scientists at the Crime Lab to provide feedback to the medical providers who collect the SAECKs (Sexual Assault Evidence Collection Kits); the scientists evaluate each kit during analysis for collections done well and for opportunities for improvement and provide that information to the coordinator. That information is then shared directly with each medical provider.

SSCs work to facilitate communication between SANE programs across Idaho. To do this, they have a quarterly meeting of Idaho SANE program Leaders (ISPL). They also prepare and distribute the Idaho SANE Program Newsletter and monthly emails to all SANEs trained in Idaho and ISPL.

The formation of a new Idaho State Police Forensic Services facilitated SART (Sexual Assault Response Team) in Benewah County helped facilitate the opportunity to SANE train 3 RN's who now offer exams to adolescents and adults. Prior to exams being offered in Benewah County patients had to travel 110 miles round trip for a SANE exam.

Provision of Technical Assistance:

The coordinators are available for technical assistance calls and have provided assistance/information regarding:

- Real-time assistance (over the phone) with exams.

- Law enforcement and medical providers requesting assistance with IKTS.
- Sharing medical protocols for evidence collection.
- Disseminating information from the CDC (Centers for Disease Control) regarding current recommendations for testing and treatment of sexually transmitted infections.
- Information on resources that support that Law Enforcement should NOT attend the medical forensic exam and history taking.
- Handling expired kits properly.
- Other states seeking assistance implementing a kit tracking system.
- Assisting prosecutors finding an expert witness.
- Provision of standards of care related to strangulation.
- Connecting a sexual assault survivor with Crime Victims Compensation (CVC) services
- providing information regarding a new law that impacts CVC and proof of US citizenship and eligibility for benefits.
- Availability of SANE-A courses and 2-day skills sessions.
- Questions regarding minor consent.
- Resources for ordering supplies needed for SANE exams.

Networking of leaders is important to promote standardized care and provide professional support; the SANE/SART Coordinator continues to facilitate the ISPL (Idaho SANE Program Leaders) group to provide networking and support. The group meets quarterly to discuss issues of concern; some topics included new program formation, changes in the CDC Guidelines for sexually transmitted infections, updates in strangulation exams and imaging guidelines, suggestions for changes to Idaho statutes specific to our patient populations, and payments for exams.

The Coordinator will begin soliciting input for updates to the Idaho Sexual Assault Response Guidelines in early 2026 and will oversee that process throughout the year.

Facilitation of the Development of SARTs (Sexual Assault Response Teams):

The coordinator continues to be available as requested to attend community SARTS providing requested education and/or assistance. One jurisdiction recently contacted the coordinator to request facilitation of communication between disciplines (healthcare, advocacy, law enforcement, or prosecution) to improve collaboration in their communities and form a SART. Meeting will be scheduled in March 2026 to provide education and start building a positive working relationship with all disciplines.

In 2025, the SSC and ISPFS Headquarters began working with Benewah County in the formation of a SART. Assistance with policies, documentation, equipment and training for staff have been provided.

In August, the SSC and ISPFS Headquarters conducted a training for the Mini-Cassia SART (Minidoka and Cassia counties). The training focused on the following:

- What a SANE is.
- The responsibilities of a SANE.

- The lab's DNA testing capabilities.
- The process of a sexual assault kit (from collection to the lab, and back).
- IRAD (Idaho Risk Assessment of Dangerousness) and how to utilize it in the field.

Program Development:

The SSC continues work on the development of the *Idaho Response to Strangulation Manual* with a multi-disciplinary team. This manual will serve as both an educational and resource guideline for not only healthcare providers, advocates, law enforcement, and prosecution, but also EMS/first responders, dispatch, and judges. The manual will contain information related to Crime Victims Compensation to help increase the information known about this Idaho program and will demonstrate the need for evidence collection in a strangulation incident.

In 2025 the SSCs developed a SANE 8-hour refresher course for nurses who have completed the 40-hour course. The course provides up-to-date evidence collection, kit packaging, documentation, maintaining chain of custody, trauma informed care, Vicarious Trauma, Self Care, recent changes with CVC (Crime Victims Compensation) and clinical skills training using mannequins. This course advances clinical competency and bolsters professional confidence in the specialized care of survivors of sexual assault and domestic violence.

There remains a significant need for the two-day Skill Class for nurses who have completed the 40-hour SANE-A training. The current SSC requires further training, and a second coordinator needs to be brought on and trained. Funding will also have to be secured to pay for the live models, this is out of the bandwidth for the current program. A federal grant to support these training courses has been written and submitted and (as of this publication date) ISPFS has not been informed about the status of this potential award funding.

SANE Supplies and Resources

In 2022, ISPFS was awarded \$200,000 from the Idaho Council on Domestic Violence and Victim Assistance (ICDVVA) to support critical equipment purchases throughout the state of Idaho that would aid in forensic exams for sexual assaults and provide trauma-informed statewide law enforcement training. Continuing into 2023, the additional funds totaled \$19,100. ISPFS used this grant to contract with Retired Detective Angela Weekes Consulting to provide the education and training to one hundred and thirty-five (135) law enforcement personnel regarding: 1) the neurobiology of trauma, 2) how sexual assault survivors may process and recall events, 3) trauma-informed interview techniques, 4) tonic immobility.

In addition to training, supplies were provided three (3) medical facilities including Teton Valley Hospital (Driggs), Valor Health (Emmett), and Gritman Medical Center (Moscow). Most of this work, training, and the procurement of equipment and supplies took place in 2023, while the remainder, and the closing of the grant took place in 2024. ISPFS continues to monitor any needs of collection sites throughout Idaho with regular visits from the ISPFS SANE/SART Coordinator.

Commendations

The ISPFS biology/DNA database team is applauded for all their hard work screening and processing sexual assault evidence collection kits. Despite staffing challenges and the need to complete processing of all non-sexual assault evidence submissions, they processed over 500 kits. Their commitment to improving processing efficiency for the citizens of Idaho is praiseworthy.

The Idaho SANE/SART Coordinators have done an amazing job performing training all over Idaho. They have worked to set up SART programs throughout the state, and many hospitals are now collecting sexual assault evidence collection kits that never had that ability before. Idaho leads the country in training SANE nurses and addressing sexual assault response issues. They have networked Idaho's SANE programs so that they are communicating and sharing information. They publish a newsletter and have many other methods of communication. Under their leadership, these positions have become an integral part of addressing sexual assault response issues in Idaho.

The Idaho State Sexual Assault Response Team (ISSART) working group has been very helpful in their efforts. This volunteer policy advisory group dedicates hundreds of hours to this important work. The work of each member is vital, and this group is critical to the success of this initiative. The work of this group in researching current problems and recommending solutions is essential to address sexual assault in Idaho. This group is leading a cultural shift in how sexual assault response is viewed and addressed throughout Idaho. It is truly a one-of-a-kind committee in the United States and is another example of Idaho's leadership on sexual assault response.




