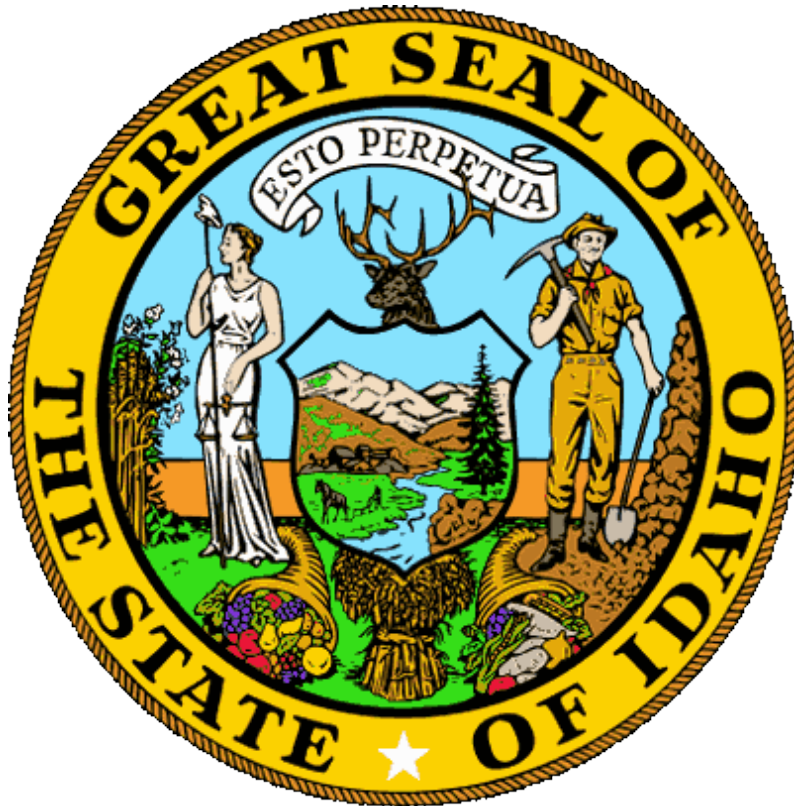

## **Introduction**

Idaho Code Chapter 29, Title 67, Section 67-2919 requires Idaho State Police Forensic Services (ISPFS) provide a legislative report regarding sexual assault evidence collection kits in Idaho on or before January 20<sup>th</sup> of each year regarding the examination of sexual assault evidence collection kits throughout the state in the previous year. The report shall include, but not be limited to, the number of kits purchased and distributed by Idaho State Police Forensic Services, the number of kits collected by each law enforcement agency, the number of kits tested by the Idaho State Police Forensic Services laboratory, the number of kits not submitted to the Idaho State Police Forensic Services laboratory pursuant to subsection (8) of the statute, the number of DNA database hits from sexual assault evidence kits, the number of unresolved DNA database hits from sexual assault evidence kits for each law enforcement agency, the number of sexual assault evidence kits submitted without required reference samples for each law enforcement agency, and a list of any law enforcement agencies that did not adhere to the tracking process promulgated pursuant to subsection (9) of the statute. This report also contains updates made to the Idaho Sexual Assault Kit Tracking System (IKTS), statistics from the ISPFS crime lab, information about the Idaho SANE/SART training program, and issues related to sexual assault evidence collection kit tracking and processing during the 2022 calendar year.

## **Executive Summary**

## **Idaho Sexual Assault Kit Tracking System (IKTS)**

In January of 2017, Idaho became the first state to fully implement a statewide sexual assault evidence collection kit tracking system. This tracking system provides greater public accountability and transparency, provides more resources to the state forensic laboratory, and ultimately provides more transparency to victims of sexual assault. Sexual assault survivors and the public can track the sexual assault evidence collection kit without having to have a login. Survivors are provided a tracking number for their kit at the time of collection. Use of this

system has resulted in several survivors asking additional questions of law enforcement, the forensic lab, and Idaho legislators.

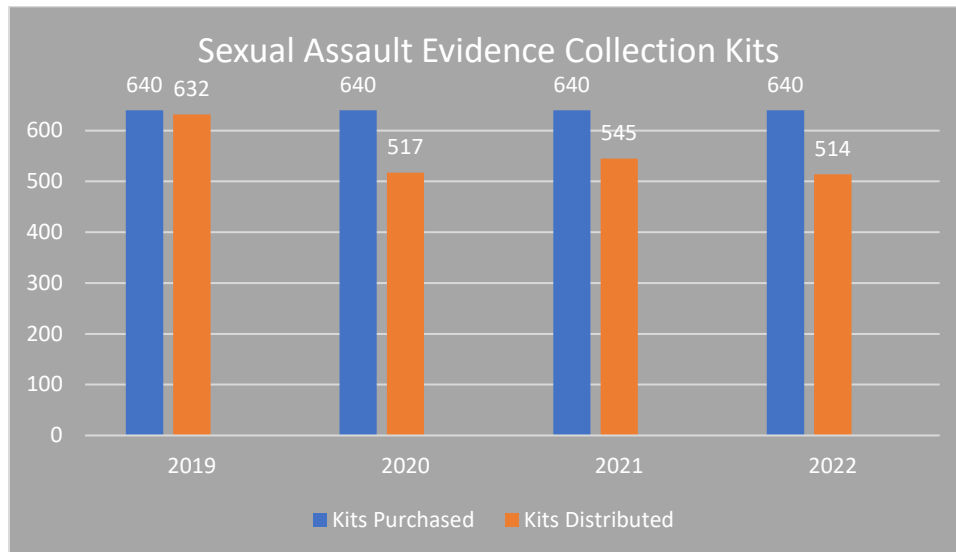
## **Training and Sharing IKTS**

The ISPFS IKTS Administrator provided training and met with several medical and law enforcement organizations throughout the past year. PowerPoint presentations on how to use IKTS for every type of organization were updated and distributed to any IKTS user that was added to the system or needed additional education.

The IKTS software is provided free of charge to any publicly funded entity that would like to adopt the program. ISPFS provides the digital download of the software program. Some organizations modify it slightly for their specific needs, while others use it to develop their own custom kit tracking system. In 2022, several states made inquiry about the system. See **Appendix A** for a list of organizations and their status with the Idaho software.

## **Sexual Assault Evidence Collection Kits purchased & distributed**

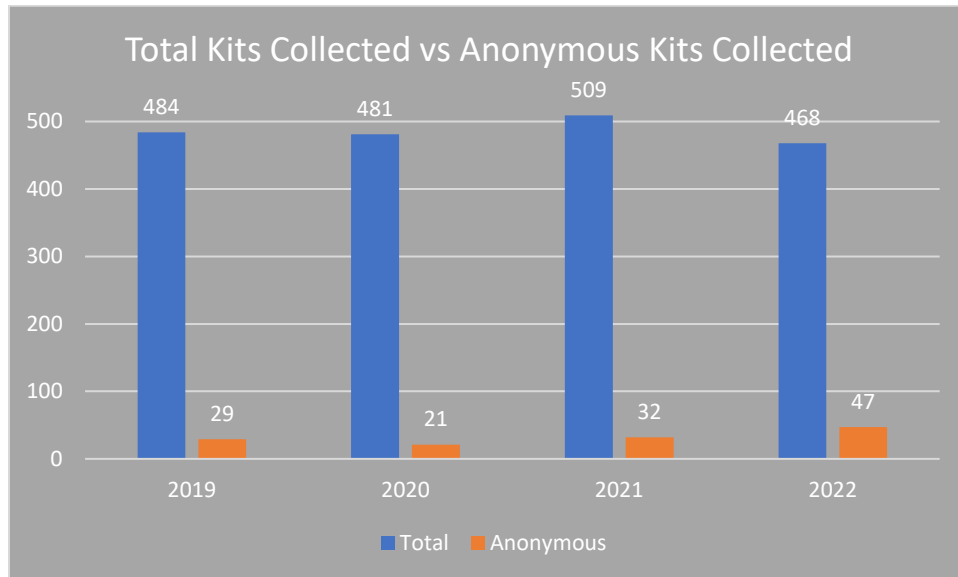
Idaho State Police Forensic Services procures the sexual assault evidence collection kits with a legislative appropriation within state purchasing rules and agreements. The new kits are entered into the IKTS system by ISPFS using a unique serial number on the box. The kits are then distributed to hospitals, clinics, and other collection entities in Idaho. A comparison of past years inventory is displayed below:



There were some challenges with the procuring sexual assault evidence collection kits at the start of 2022 due to supply chain disruptions. However, we were able to mitigate the problem. We continue to monitor supply chain issues to ensure Idaho has collection kits available.

## Sexual Assault Medical Forensic Examinations

Hospitals and clinics in Idaho, and surrounding states, perform sexual assault medical forensic examinations. When custody of a kit collected in another state is turned over to an Idaho law enforcement agency, it is assigned an Idaho serial number and tracked from that point forward in the IKTS system. 468 kits were collected in Idaho in 2022 and 47 of those were anonymous.



## Law Enforcement (LE) Information

All sexual assault evidence kits collected in Idaho, and the allegation has not been determined to be unfounded, shall be processed by the Idaho State Police Forensic Services laboratory. Exclusions include kits of victims who wish to remain anonymous under the provisions of the federal Violence Against Women Act (VAWA).

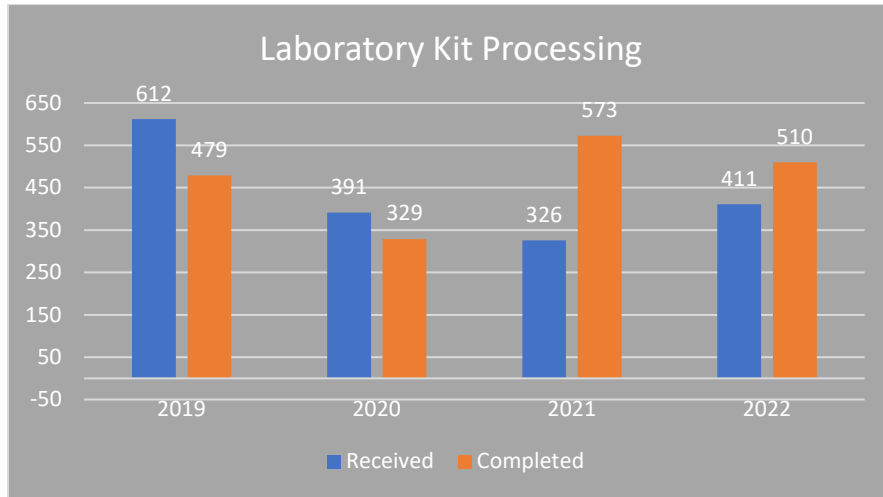
Law Enforcement agencies are required to obtain the sexual assault evidence collection kit from the collection facility, and either submit the kit to ISPFS for analysis or document the decision not to test in the IKTS system. A list of participating LE agencies is outlined in **Appendix B**.

Any sexual assault evidence collection kit, excluding anonymous kits, that are not submitted to the lab for testing must be independently reviewed by the county prosecutor. **Appendix C** outlines the sexual assault kit decisions by agency. Kits that were collected anonymously but were not tested under the federal Violence Against Women Act (VAWA), are presented in **Appendix D**.

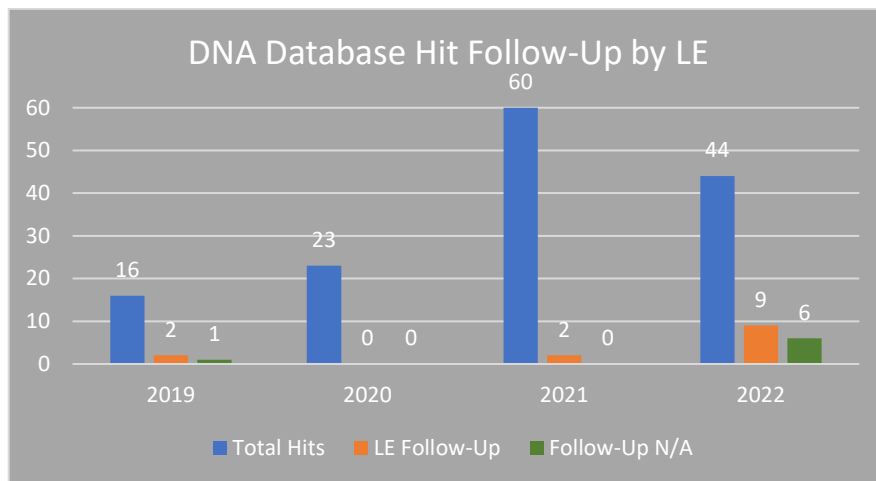
Often sexual assault evidence collection kits need reference samples from either suspects or consensual partners. It is a constant challenge for law enforcement to collect these sample after the initial crime report. **Appendix E** outlines the number of sexual assault evidence collection kits completed by ISPFS during 2022 that lacked required reference sample submission.

## ISPFS Laboratory Analysis

Throughout 2022, ISPFS continued to struggle to fill open DNA positions due to lack of qualified candidates and low pay. New hires are typically new to the field and require two (2) years to fully complete training. We currently have two fully trained federal grant funded contractors working remotely in other states contributing to the success of the DNA program. At this time, we have two grant funded vacancies that have not been successfully filled. ISPFS will attempt to fill these vacancies in 2023.



**Appendix F** reflects the number of DNA database hits from sexual assault evidence collection kits and the number of those hits that are unresolved by law enforcement agency.



## **The Idaho Sexual Assault Kit Initiative (ISAKI)**

The Idaho Sexual Assault Kit Initiative (ISAKI) working group was founded by ISPFS in 2014. This volunteer multidisciplinary policy advisory group consists of state and local law enforcement, specialty organizations representing varying agencies, the forensic laboratory personnel, prosecutors, a public defender, a judge, a court representative, several victim advocacy and resource groups, victim compensation fund administrators, sexual assault nurse examiners (SANEs), a physician, hospital administrators, grant experts, and a state Senator. This group meets every quarter to discuss issues that occurred throughout the state of Idaho. Issues are assessed regarding the level of service and care to victims, increase sexual assault training for law enforcement, mandatory reporting guidelines, and how to properly address anonymous sexual assault evidence collection kits.

For this past calendar year, the ISAKI working group completed or updated the following items:

- The Idaho Sexual Assault Response Guidelines were reformatting and updated
- The Best Practices for the Medical Forensic Examination was re-written.
- The Professional Resources List was updated
- The Uniform Evidence Protocol for examination and investigation was added
- Language that speaking with the victim privately during an interview ensures they can speak freely was added
- Gender identity was added for consideration of cultural sensitivity
- Patient identification INSIDE the kit for anonymous SAECKs was clarified
- Guidance for collection of the SAECK was expanded
- Patient Options Form, no longer being used by organizations, was removed

## **Challenges to Kit Tracking**

Throughout the year, there have been some challenges related to the IKTS program, with some previous challenges being overcome. One major challenge that has plagued the IKTS program has been the pay for this position. In this past year, the IKTS Administrator position was converted from an Administrative Assistant to a Management Assistant with an associated pay increase. We anticipate the change to this position will aid in retention. Some of the challenges to the IKTS tracking program are outlined below:

- There has been high turnover for medical and law enforcement personnel throughout the state. The challenge of ensuring IKTS users are correct and trained for organization(s) is constant.
- Law enforcement organizations have been changing their email address formats and not updating IKTS email addresses. This has caused delays in contacting these organizations. Some organizations are not completing the information for collected sexual assault

evidence collection kits or updating their status in IKTS. This is a daily endeavor reaching out to organizations for the required information.

- SANE-A classes are offered, and attendees are required to sign up in advance. This ensures there are enough participants for the class and best utilizes the funding for travel, materials, etc. for each class. There have been several occasions when an attendee(s) cancelled at the last minute or did not show up for the class. This has resulted in classes being cancelled last minute as it is not economically feasible to teach the class without a minimum number of participants. ISPFs is seeking input from ISAKI to address this.

The IKTS Administrator and other ISPFs staff offer training in person or online for any organization that would like to have additional information. Unfortunately, most organizations have not accepted the invitation for this training.

## **IKTS Software Development and Use Statistics**

IKTS is continually enhanced by Idaho State Police web programmers. Having IT programmers at ISP allows the IKTS administrator to make real time changes to the system as the process has been refined. See **Appendix G** for the annual IKTS use statistics for 2022.

## **Idaho SANE/SART Coordinator Position**

The Idaho SANE/SART Coordinator (SSC) continues to oversee and administer a training program to increase the number of SANE trained nurses, develop a sustainable training program for entry-level and continuing SANE training, maintain the statewide sexual assault response guidelines, coordinate the efforts of the ISAKI group ongoing initiatives, ensure implementation and continual review of state sexual assault evidence collection policy and procedures, and help coordinate resources and other operational issues in all Idaho sexual assault evidence collection facilities.

### **Competence and Practice**

Throughout 2022, the SSC herself completed 78.5 hours of continuing nursing education specific to SANE nursing. Additionally, she has complete education that does not provide nursing education hours, on topics including: dating app facilitated assault, online dating assaults, state-wide tracking systems for SA kits, strangulation, teleSAFE programs, expanding SANE resources in rural and underserved communities, photo-documentation in SANE exams, human trafficking, violence against males, at-home sexual assault kits, sexually transmitted infections, case review, the Art of SARTs: Imbedding Prevention, and more. The SSC was awarded a certificate as an Intimate Partner Violence Nurse Examiner. With this certification, she can now educate others on this aspect of violence in the 40-hour SANE class instruction. In 2022, the SSC worked 550 SANE call hours to ensure she remains competent in the provision of care for the patient.



## Improving Access to Standardized Care after Sexual Assault

Eleven (11) 40-Hour SANE courses were scheduled for 2022. Two of those were canceled due to nurses canceling, but with the remaining nine classes educated 45 nurses. The SSC assisted as Instructor in educating 31 law enforcement personnel in a two 2-day skills labs. One jurisdiction requested the SSC provide specific training on strangulation. This is an example of the ability to tailor the education to the needs of the agency.

The SSC has focused on encouraging nurses who have been trained to test for the International Sexual Assault Nurse Examiner certification to promote excellence in forensic nursing. When the SSC position was initiated, there were only 12 certified nurses in the state and several of them let that certification expire. As of December 2022, Idaho now has 17 SANE-A's (Sexual Assault Nurse Examiners – Adults/Adolescents) and 5 SANE-P's (Sexual Assault Nurse Examiner – Pediatrics). All five of the SANE-P's are dual-certified as both SANE-A and SANE-P. While those numbers seem low, they compare closely to other states in the Pacific Northwest:

With grant funding of \$200,000 from the Idaho Council on Domestic Violence and Victim Assistance, ISP was able to procure and disseminate additional equipment for Idaho SANE programs. The largest expense was the purchase of eight highly sophisticated photography systems (Cortexflo) to assist SANEs in photo-documentation of injuries sustained in an assault. The system can securely store the photographs to ensure that access to the photographs is highly restricted. Other equipment requested for the program were exam tables, patient stretchers, SANE carts, swab driers, alternate light sources, and a security cabinet and refrigerator for medications.

The SSC continues to work with the Forensic Scientists at ISPFS to provide feedback to the medical providers who collect the SAECKs (Sexual Assault Evidence Collection Kits). The scientists evaluate each kit during analysis for collections done well and for opportunities for improvement and provide that information to the SSC. That information is then shared directly with each medical provider. Anonymous pediatric kit collection has stopped, but overall evidence collection has improved.

A major success was the establishment of a SANE program at the Ft. Hall Tribal Health Clinic. The SSC worked very closely with a nurse she had trained to assist in the development of protocols and a documentation system. The SSC was asked to attend two Tribal District Meetings to discuss the implementation of SANE programs at other Tribal Health Clinics in Idaho. The SANE Program Manager at Ft. Hall Tribal Health Clinic is hopeful that having the ability to have access to a SANE exam close to home will have an impact on the high suicide rates the tribes are experiencing.

### **Provision of Technical Assistance:**

The SSC is available for technical assistance calls and has provided:

- Real-time telephonic assistance with exams
- Law enforcement and medical providers with assistance with IKTS
- Medical protocols for evidence collection
- Information from the CDC (Centers for Disease Control) regarding changes in the treatment of sexually transmitted infections
- Protocols for advocacy with inmate exams
- Information about handling expired kits properly
- Assistance/direction for exams in other states when they don't have a SSC
- Assistance for prosecutors trying to locate an expert witness
- Provision of standards of care related to strangulation

Networking of leaders is important to promote standardized care and provide professional support. The SSC created and facilitates the ISPL (Idaho SANE Program Leaders) that meets quarterly to discuss issues of concern. In 2022, topics included new program formation, changes in the CDC guidelines for sexually transmitted infections, updates in strangulation exams and imaging guidelines, suggestions for changes to Idaho Statutes specific to our patient populations, and payments for exams.

The SSC will begin soliciting input for updates to the Idaho Sexual Assault Response Guidelines in early 2023, and will oversee that process throughout the year.

### **Facilitation of the Development of SARTs (Sexual Assault Response Teams):**

The SSC continues to be available for education and assistance to the community SARTs. Two jurisdictions have contacted the SSC to request facilitation of communication between disciplines (healthcare, advocacy, law enforcement, or prosecution) to improve collaboration in their communities for both SANE and suspect exams. This is a slow and methodical process, and with time, improvement in team performance and provision of care will be seen.

### **Improving Community Awareness of Sexual Assault and Community Responses:**

With the Idaho State Police Forensic Services Laboratory System Director, the SSC participated in a 2-day ten-hour webinar hosted by the United States Institute of Justice's Forensic

Technology Center of Excellence (FTCOE) related to the work being done in Idaho to improve forensic care. The SSC role embedded in the ISPFS Lab was discussed, as was data analysis of the work being done. There were over 500 attendees from several countries, and the webinar is archived and available on the FTCOE site.

The ISP Lab System Director and SSC have also been asked to sit on the IAFN (International Association of Forensic Nurses) OVC SANE Program TTA 2021 Partner Community to assist in the provision of technical assistance to several new forensic programs across the US. The SSC has been asked to sit on the IAFN Conference Planning Committee for the 2023 Annual Scientific Forensic Conference being held in Phoenix.

The SSC is working with ISP's Video Production Specialist to film presentations related to forensic nursing for both medical providers and law enforcement.

### **Program Development:**

The SSC will be moved to state funding in 2023. The SSC will no longer be limited to the provision of adolescent/adult care only and will begin the development of a pediatric SANE course. Programs across Idaho have shared anecdotally that they see three child victims of sexual assault for every one adolescent/adult victim, and the need for pediatric specific education is urgent.

The ISAKI group has asked the ISP Lab System Director to seek grant funding for a second forensic nurse. The nurse hired into that position will primarily be responsible for teaching most of the SANE-A courses and assist with other education. A second forensic nurse will also allow for expansion of other needed education related to sexual assault, such as intimate partner violence and additional education for law enforcement.

Other possible projects include the development of: 1) a consistent state-wide forensic medical record, 2) a state protocol for the retention and destruction of the forensic medical record to ensure it is available for the life of the SAECK, 3) team building for SARTs, 4) collaboration with Title IX Officers for care of the sexually assaulted on Idaho college/university campuses, 5) collaboration with Safety Resource Officers on school campuses.

## **SANE Supplies and Resources**

ISPFS was awarded \$200,000 from the Idaho Council on Domestic Violence and Victim Assistance to support critical equipment purchases throughout the state of Idaho to aid in forensic exams for sexual assaults and provide trauma-informed statewide law enforcement training. Angela Weekes Consulting provided the education and training to fifty-seven (57) law enforcement personnel regarding: 1) the neurobiology of trauma, 2) how sexual assault survivors may process and recall events, 3) trauma-informed interview techniques, 4) tonic immobility. In addition, Ms. Weekes has worked with the Idaho POST staff in creating on-demand training modules for Idaho law enforcement training. These trainings include:

- Trauma informed interviewing of sexual and domestic violence survivors

- Neurobiology of trauma effects on survivors of sexual and domestic violence
- Understanding vicarious trauma for law enforcement officers investigating sexual and domestic violence
- Working effectively with SANE nurses and victim advocates for law enforcement
- SRO training on SA response and reporting in K-12 schools
- Investigating sexual assault, sextortion, and human trafficking
- Investigating sexual assault of male victims

Supplies were provided to eighteen (18) medical facilities including the startup of the Fort Hall Indian Reservation Clinic. The supplies included nine (9) CortexFlo Photographic Exam Systems, camera support items, pediatric exam tables, stretchers, and a variety of other exam items. These supplies and training will have a major and continued impact on the ability of Idaho medical facilities to provide time sensitive care and evidence collection to victims of sexual assault. ISPFS continues to monitor any needs of collection sites throughout Idaho with regular visits from the ISPFS SANE/SART Coordinator.

### **Commendations**

The ISPFS biology/DNA database team is applauded for all their hard work screening and processing sexual assault evidence collection kits. Despite staffing challenges and the need to complete processing of all non-sexual assault evidence submissions, they processed over 500 kits. Their commitment to improving processing efficiency for the citizens of Idaho is praiseworthy.

The Idaho SANE/SART Coordinator has done an amazing job performing training all over Idaho. She has worked to set up SART programs throughout the state, and many hospitals are now collecting sexual assault evidence collection kits that never had that ability before. Idaho leads the country in training SANE nurses and addressing sexual assault issues. She has networked Idaho's SANE programs so that they are communicating and sharing information. She publishes a newsletter and has many other methods of communication. Under her leadership, this position has become an integral part of addressing sexual assault issues in Idaho.

The Idaho Sexual Assault Kit Initiative (ISAKI) working group has been very helpful in their efforts. This volunteer policy advisory group dedicates hundreds of hours to this important work. The work of each member is vital, and this group is critical to the success of this initiative. The work of this group in researching current problems and recommending solutions is essential to address sexual assault in Idaho. This group is leading a cultural shift in how sexual assault response is viewed and addressed throughout Idaho. It is truly a one-of-a-kind committee in the United States, and is another example of Idaho leadership on sexual assault response.
