

BTS/BTO TRAINING

- You can access the Canvas training directly through the link: https://canvas.instructure.com/register_from_website
- Click on I'm a Student link
- Fill in the information using the join code and the username should be your agency email address.
- Your BTS' should have the join code if you are new to the system.


INSTRUCTURE

WHICH MODULES DO ITAKE?

- All users need to take the following:
 - Physiology
 - Legal Understanding of DUI
- Then you need to take the modules corresponding to the instruments that you wish to certify and use for evidential breath testing. You will not be certified on any instrument that you do not complete a proficiency test on.
- If you certify with the EasyCal performance verification unit, please note that the certification for the EasyCal does not expire.
- If certifying as a BTS, take the BTS tests. If certifying as a BTO, take the BTO tests.

CANVAS

- Once in the training, select the module you wish to complete.
- Go through the module, take the quizzes and test once you complete the module.



FLEXIBILITY?

- You do not need to complete the modules in any specific order.
- You do not need to complete the modules in any specific timeframe.
- You can start and stop the modules as you need to at any time.
- You can enter and exit the training at any time.

FLEXIBILITY?

- You will need to obtain and passing grade of 80% of better in order to proceed to proficiency testing on the instrument.
- You can pause the training for breaks.
- You can take the training over multiple days, weeks, or months if necessary.
- Your date of completion and scores for each module will be recorded in the canvas application along with training times, and testing times. However, you must take a screen capture or photo of each completed test to show your BTS or RBTC at the proficiency test.

FLEXIBILITY?

- The canvas application will allow ISP Forensics to assess the training and the students to see how each student is performing, as well as the overall performance of the class on each test question.
- This can afford ISP Forensics to see in advance if questions are confusing, poorly worded, or somehow not being addressed in a clear and concise manner in the instruction materials.
- If you have any suggestions or comments, please contact ISP Forensics and ask to speak to one of the Regional Breath Testing Coordinators about your concerns.

TRAINING COMPLETION

- Once you have completed <u>each module</u> test, PRINT, TAKE A PICTURE, SCREENSHOT, or somehow capture and record your test score to show your BTS or regional breath testing coordinator.
- You will then be directed to a web portal to enter in your test score. Contact your BTS or RBTC if the link does not work to the webpage to log your scores. On this page, enter in the score you received on your test for the module you completed.
 - The format is in <u># correct out of # of exam questions</u>. Your percentage will be automatically generated.
- Select if you are certifying as a BTS or BTO.
- Enter in your POST ID
- Submit your scores
- Your BTS or RBTC will not be able to sign you off unless you log your scores.


- Fill in your information from your training

TRAINING ALTERNATIVES

- Beginning in 2019, Forensic Services will be offering live classes for the breath alcohol certification training. These will be held at the Region 1, Region 3 and Region 5 laboratory training facilities.
- Classes will be scheduled twice a year in Region 1 (CDA) and 5 (Pocatello)
 - Once in the spring and once in the fall
- Classes will be scheduled four times a year in Region 3 (Meridian).
 - Once in each season
