

- □ 4. Pipette 500μL 0.1% formic acid in water in wells of analytical plate.

- □ 9. Add 2.25mL MTBE. (Add in 3 increments of 750uL)

- □ 11. Apply positive pressure for approx. 15 seconds. (10-15 PSI- Selector to the left).
- ≥ 12. Add 2.25mL Hexane. (Add in 3 increments of 750uL)
- \boxtimes 13. Wait 5 minutes.
- △ 14. Apply positive pressure for approx. 15 seconds. (10-15 PSI- Selector to the left).
- □ 16. Reconstitute in 100μL 100% MeOH and heat seal plate with foil. Place in autosampler and run worklist.
