Does your agency/office have unsolved homicide, sexual assault, or unidentified human remains cases? The Idaho State Police Forensic Services led Idaho Cold Case and Advanced DNA Methods (ICCADM) team is ready to help you and to fund advanced DNA testing.

The state Sexual Assault Kit Initiative (SAKI) team is part of the overall ICCADM team. The ICCADM team has state and also federal funding through a SAKI grant from the federal Bureau of Justice Assistance to work cases that need forensic analysis, including Forensic Investigative Genetic Genealogy. This grant is administered and operated by Idaho State Police Forensic Services. There is no fee to any law enforcement, prosecutor, or coroner office to access or use these services. In particular, the ICCADM team has funding to work genealogy on homicide, sexual assault, and unidentified remains cases. You do not lose any control over your case, as this team is set up to provide the help that is desired and to collaborate with your investigative team. The team has law enforcement investigators, a state lab DNA expert, a victim advocate, a genealogist, and an intel analyst as part of the team. They are a resource and a force multiplier for your investigations. Cases do not need to be "old" or "cold" to utilize this team.

We have worked together with ICOPA and ISA to ensure that this team provides assistance to the extent you would like on each case while respecting your autonomy as a law enforcement organization. Our investigators are retired, seasoned Idaho law enforcement investigators, are Idaho POST certified, and have extensive experience working in team and task force approaches to solving cases.
